



EXAMINING THE PSYCHOLOGICAL AND ETHICAL IMPACTS OF ALGORITHMIC MANAGEMENT ACROSS CULTURAL CONTEXTS IN PLATFORM LABOUR

Abstract

The expansion of the gig economy has introduced algorithmic management systems that fundamentally reshape work processes and worker experiences, raising critical concerns about worker autonomy, fairness, and psychological wellbeing. This study investigates the psychological and ethical implications of algorithmic surveillance on gig workers' wellbeing across four countries using a cross-sectional survey of 1,204 respondents. Drawing on theories of techno-stress and algorithmic control, the analysis employs multilevel modeling, mediation, and moderation techniques to explore the direct, indirect, and context-dependent effects of surveillance. The results reveal a strong negative association between surveillance intensity and psychological wellbeing (-4.213), partially mediated by perceptions of unfair algorithmic decision-making (indirect effect = 2.548). Furthermore, cultural dimensions significantly moderate this relationship: high power distance amplifies the negative effects of surveillance, while individualism mitigates them. These findings indicate that algorithmic surveillance systems may exacerbate psychological distress among platform workers, especially in hierarchical or collectivist cultures. The study recommends that platform operators adopt fairness-by-design and culturally sensitive algorithmic management practices. Policymakers are urged to develop enforceable standards for algorithmic transparency and worker participation in digital governance frameworks.

INTRODUCTION

The rapid expansion of the gig economy has transformed traditional labour relations, introducing new forms of algorithmic control and surveillance into work arrangements. Platforms like Uber, Deliveroo, and TaskRabbit rely heavily on algorithmic management systems that track, rate, and control worker behaviours through digital platforms (Ivanova et al., 2022). These systems, while optimising efficiency and standardising service delivery, raise critical concerns about workers' autonomy, privacy, and psychological wellbeing. As algorithmic oversight becomes the norm in gig-based work, there is an urgent need to examine how these practices affect the lived experiences and mental health of gig workers across different cultural and regulatory contexts (Veen et al., 2020).

The rise of algorithmic management in the gig economy presents a critical challenge to worker wellbeing, which is essential for achieving goal congruence between workers and platform organizations. While algorithmic management promises operational flexibility and efficiency, it often imposes intense surveillance and control mechanisms that undermine workers' autonomy, agency, and psychological health (Wood et al., 2021). This tension creates a significant problem:

how to balance organizational objectives driven by digital monitoring with the need to preserve worker wellbeing, which is foundational for sustained productivity, job satisfaction, and reduced turnover. Without addressing this balance, platforms risk alienating their workforce and compromising long-term operational effectiveness.

The nexus between the independent variables—surveillance intensity, perceived fairness, cultural orientations, and national regulatory frameworks—and the dependent variable, employee wellbeing, is central to understanding this problem. High levels of workplace surveillance typically elevate psychological strain, manifesting in increased anxiety, job dissatisfaction, and burnout, thereby disrupting the alignment of worker and organizational goals. However, this relationship is complex and context-dependent. Research suggests that cultural dimensions such as collectivism versus individualism, as well as the strength of labour protections, mediate the impact of surveillance on wellbeing (Kellogg et al., 2020; Duggan et al., 2021). For example, workers in societies with stronger regulatory safeguards or collectivist norms may interpret surveillance differently, experiencing less adverse psychological effects, which in turn affects their engagement and performance.

Despite extensive studies in Western contexts highlighting the precariousness and erosion of employment protections within gig work, there is a notable gap in comparative research examining how these effects vary across diverse socio-cultural and institutional environments. This study aims to fill this gap by investigating the psychological and ethical implications of algorithmic surveillance across six countries with varied cultural and regulatory landscapes: the United States, United Kingdom, Germany, India, Nigeria, and Brazil. By elucidating how surveillance intensity and perceived fairness influence employee wellbeing dimensions such as job satisfaction, anxiety, and burnout, this research advances understanding of how to foster goal congruence through enhancing worker wellbeing amidst digital labour's evolving landscape.

Ultimately, addressing the problem of algorithmic management's impact on worker wellbeing is not merely a theoretical pursuit but a practical imperative. Ensuring psychological safety and dignity in digitally mediated workplaces is crucial for ethical innovation and sustainable platform growth. This requires localized, culturally informed approaches to algorithmic governance that integrate transparency, fairness, and participatory mechanisms to mitigate harm and promote alignment between workers' needs and organizational goals (Qiu & Graham, 2022).

The study offers important theoretical and practical implications. Theoretically, it challenges universalist assumptions about the effects of digital surveillance by emphasizing the role of cultural and institutional contexts. Practically, the findings underscore the need for platform companies and policymakers to consider localized responses to worker surveillance, ensuring that technological innovation does not come at the cost of human dignity and psychological safety. Ethical algorithm design, improved communication transparency, and participatory governance models are recommended to mitigate harm and enhance worker wellbeing.

LITERATURE REVIEW

Conceptual Clarification

The concept of workplace surveillance in gig work primarily refers to the monitoring and control of workers' activities through digital technologies, often embedded within platform algorithms. These algorithmic systems, central to algorithmic management, govern task allocation,

performance evaluation, and disciplinary actions without direct human mediation. This shift represents a departure from traditional supervisory practices toward automated and data-driven oversight, which can obscure decision-making processes and reduce transparency for workers (Ivanova et al., 2018; Rosenblat & Stark, 2016).

Algorithmic management operates through continuous data collection and real-time behavioral tracking, effectively surveilling workers' time, location, and performance metrics. This dynamic introduces novel dimensions of worker autonomy and control, where flexibility in scheduling is counterbalanced by intense monitoring and performance pressures. Consequently, gig workers often navigate a paradoxical environment characterized by both increased freedom and heightened precarity, underscoring the complex nature of algorithmic labor regimes (Wood et al., 2019; Newlands, 2021).

Additionally, algorithmic management impacts psychological wellbeing, shaping emotional responses such as stress, anxiety, and burnout. These effects are mediated by workers' perceptions of fairness, transparency, and control, which vary cross-culturally and are influenced by institutional contexts (Zhang et al., 2023; Duggan et al., 2022). Emerging concepts such as sousveillance, where workers use digital tools to monitor and counteract managerial surveillance, highlight the importance of worker agency and resistance within algorithmic regimes (Hernandez et al., 2024). Furthermore, evolving digital interfaces and platform designs also represent important areas where technological affordances can either exacerbate or alleviate algorithmic burdens (Suvarnapathaki et al., 2025).

Thus, workplace surveillance and algorithmic management in gig work are multifaceted constructs that integrate technological, social, and psychological dimensions, requiring nuanced conceptualization that recognizes the interplay between control, autonomy, resistance, and wellbeing.

Theoretical Review

Understanding the effects of workplace surveillance and algorithmic management in gig work benefits from several theoretical perspectives that illuminate the power dynamics, psychological impacts, and socio-cultural contingencies embedded in platform labor. At its core, Foucault's theory of surveillance and power offers a foundational lens, wherein algorithmic management is conceptualized as a modern form of panopticism. Through continuous digital monitoring, workers internalize surveillance, regulating their own behavior under the assumption of being watched, thereby producing self-discipline and compliance without direct supervision (Ivanova et al., 2018; Rosenblat & Stark, 2016). This framework explains how platform algorithms extend managerial control while obscuring the loci of power, intensifying precarity and diminishing workers' capacity for contestation.

Complementing this, Job Demand-Resources (JD-R) theory provides a psychological perspective on how algorithmic management shapes workers' wellbeing. According to JD-R, algorithmic control introduces heightened job demands, such as constant performance monitoring and time pressures, which can lead to strain, emotional exhaustion, and burnout (Zhang et al., 2023; Moeller et al., 2023). However, resources like perceived autonomy, social support, and fairness may buffer these negative effects. This theory captures the dual experience of gig workers who,

despite engaging deeply with their work, suffer psychological costs due to the stressful demands imposed by opaque algorithmic systems.

Moreover, cultural dimensions theory, particularly Hofstede's model of power distance, sheds light on the cross-cultural variation in workers' responses to algorithmic management. Chen et al. (2022) demonstrate that in high power-distance societies, such as India and China, stronger algorithmic control correlates with reduced perceived autonomy and psychological safety. In contrast, trust-based cultural orientations can mitigate the harmful psychological effects of surveillance. These insights underscore that institutional and cultural contexts critically shape how algorithmic power is experienced and contested.

Theories of resistance and worker agency further enrich understanding by foregrounding how gig workers deploy digital tools and social networks to challenge managerial oversight. The concept of *sousveillance*, whereby workers reverse surveillance through self-monitoring and advocacy, exemplifies emergent forms of digital resistance that complicate simplistic notions of worker subjugation (Hernandez et al., 2024). Additionally, user interface design theories emphasize the potential for participatory technology development to reduce algorithmic burdens and enhance worker control (Suvarnapathaki et al., 2025).

Finally, institutional theories highlight the regulatory and policy dimensions affecting algorithmic labor. Cross-national analyses reveal a significant regulatory vacuum, with varied worker protections and degrees of unionization influencing the scope for algorithmic transparency and accountability (Financial Times, 2025; Wired, 2022). This points to the importance of integrating institutional frameworks with worker-led initiatives to foster fairer gig economies. Together, these theoretical perspectives provide a comprehensive foundation for analyzing the complex, multi-layered impacts of workplace surveillance and algorithmic management on gig workers, emphasizing power relations, psychological wellbeing, cultural contexts, and resistance strategies.

Empirical Review and Hypotheses Development

Algorithmic surveillance intensifies control over gig workers and constrains their autonomy, culminating in diminished psychological wellbeing. Multiple studies illustrate how platform-based algorithmic demands generate high workload, time pressure, and emotional strain (Baiocco et al., 2022; Kellogg et al., 2020; Möhlmann & Zalmanson, 2017), while depriving workers of meaningful decision-making (Ivanova et al., 2018; Duggan et al., 2020). Indeed, such surveillance creates asymmetrical power dynamics where workers experience constant monitoring without transparency, often leading to anxiety, burnout, and detachment (Kellogg et al., 2020; Baiocco et al., 2022; Wood et al., 2019; Gregory, 2021). Empirical evidence also connects algorithmic nudging to heightened psychological strain, particularly when coupled with punitive mechanisms and opaque metrics (Ivanova et al., 2018; Rosenblat & Stark, 2016; Woodcock, 2020). Drawing from the Job Demands–Resources model, excessive surveillance operates as a job demand that depletes psychological resources, thereby eroding workers' wellbeing (Bakker & Demerouti, 2017). Consequently, the paper expects:

H₀₁: Algorithmic surveillance is negatively associated with gig workers' psychological wellbeing.

While surveillance exerts direct pressure on workers, perceptions of unfairness in algorithmic decision-making mediate this negative relationship by exacerbating stress and eroding trust.

Studies identify a strong link between opaque, procedurally unjust systems and emotional exhaustion, depression, and work alienation (Woodcock, 2020; Ivanova et al., 2018; Rosenblat & Stark, 2016). Brokerage and deactivations without recourse intensify feelings of injustice and unpredictability (Woodcock, 2020; Duggan et al., 2020). Algorithmic fairness literature underscores this: perceptions of unfairness significantly explain variances in job satisfaction and emotional wellbeing (Starke et al., 2021; Dolata et al., 2021), while workers exposed to inequitable evaluations exhibit higher signs of emotional distress (Moore, 2018; Ball, 2021). Research also points to procedurally unfair systems as primary stressors that mediate the impact of surveillance on wellbeing (Woodcock, 2020; Ivanova et al., 2018; Starke et al., 2021). Therefore:

H₀₂: Perceived unfairness in algorithmic decision-making mediates the relationship between surveillance intensity and psychological wellbeing.

The adverse effects of algorithmic surveillance on wellbeing are contingent on cultural context - shaped by values such as power distance and individualism. In high power-distance societies, surveillance may be normalized, but the absence of transparency can undermine trust and exacerbate stress (Chen et al., 2022; Qiu & Graham, 2022). In contrast, individualistic cultures, which prioritize autonomy and self-determination, make workers more sensitive to perceived intrusions and risks to self-agency (Zhang et al., 2022; Kellogg et al., 2020). Cross-cultural studies observe that surveillance's psychological burden is moderated by cultural orientations towards authority and autonomy (Zhang et al., 2022; Qiu & Graham, 2022; Duggan et al., 2022). Further, individual reactions to algorithmic control vary depending on cultural appraisal frameworks: collectivist workers may tolerate rigid systems when perceived as group-oriented, whereas individualist workers resist them (Pei et al., 2021a; Wood et al., 2019; Chen et al., 2022). Thus:

H₀₃: The relationship between algorithmic surveillance and psychological wellbeing is moderated by cultural dimensions such as power distance and individualism.

METHODOLOGY

This study employs a mixed-methods research design comprising cross-sectional survey data and qualitative interviews collected from gig economy workers in four culturally distinct countries: the United Kingdom, India, Indonesia, and the United States. These countries were purposefully selected to reflect variations in cultural dimensions such as power distance, individualism, and regulatory environments. The final sample consists of 1,204 respondents recruited through targeted online platforms including Reddit, Prolific, and Facebook groups for Uber, Deliveroo, GoJek, and Swiggy drivers. The structured questionnaire measured constructs such as algorithmic surveillance, perceived fairness, psychological wellbeing, and demographic controls. Cultural dimension indices were matched using Hofstede Insights (2023). The qualitative component involved 26 semi-structured interviews thematically analyzed to contextualize survey results. Data collection was conducted between February and April 2025.

The core model evaluates the impact of algorithmic surveillance on gig workers' psychological wellbeing. A multilevel linear regression model accounts for the nested structure of individuals within countries. The primary specification is expressed as:

Where: Wellbeing_{ij} represents the psychological wellbeing of individual i in country j , Surveillance_{ij} captures perceived algorithmic surveillance, Fairness_{ij} reflects perceived decision-making fairness, u_j is the country-level random intercept, and ϵ_{ij} is the individual-level error term.

To test the mediating effect of fairness, the mediation model is specified using Baron and Kenny’s (1986) approach extended for multilevel data:

The moderating effect of cultural dimensions is evaluated via interaction terms:

Where Culture_j includes Hofstede’s indices of power distance and individualism.

We employ multilevel modeling (MLM) due to the hierarchical structure of the data which allows for random intercepts at the country level. This accounts for both individual- and group-level variance (Snijders & Bosker, 2012). The mediation analysis is executed using the multilevel path modeling framework with Monte Carlo confidence intervals (Preacher et al., 2010). ANOVA is used for initial group comparisons to detect differences in wellbeing by country and gig platform. The robustness is assessed through alternative wellbeing specifications (e.g., GHQ-12 scale); Jackknife sensitivity tests and varying cultural indices (e.g., GLOBE instead of Hofstede). Variance Inflation Factor (VIF) tests confirm multicollinearity is within acceptable thresholds (VIF < 4). Normality, homoscedasticity, and residual independence are tested through standard diagnostic plots. RESULTS AND DISCUSSION

The findings from this study offer compelling insights into the psychological implications of algorithmic surveillance in gig work settings, highlighting how algorithmic control mechanisms interact with fairness perceptions and cultural values to shape worker wellbeing. Table 2 reveals a moderate level of self-reported wellbeing among respondents (M = 58.472), yet with considerable variability (SD = 14.263). Importantly, the mean score for perceived surveillance intensity is relatively high (M = 3.841), suggesting that gig workers across platforms such as Uber and Deliveroo frequently experience tight algorithmic oversight. These values underscore the

context in which psychological strain may arise, especially when combined with a moderate perception of fairness (M = 2.912).

The correlation matrix in Table 3 supports the first hypothesis (H1) that surveillance negatively correlates with wellbeing ($r = -0.36$). This finding is consistent with the growing body of literature suggesting that algorithmic control can erode autonomy, reduce job satisfaction, and generate psychological distress (Parent-Rocheleau & Parker, 2021; Wood et al., 2020). In line with the theory of technostress and control imbalance, constant monitoring and opaque metrics appear to contribute to a perceived loss of agency, thereby diminishing affective wellbeing. Furthermore, the strong positive correlation between fairness and wellbeing ($r = 0.472$, $p < 0.01$) supports the notion that procedural justice serves as a crucial psychological buffer in algorithmically managed environments (Kellogg et al., 2020).

The ANOVA results (Table 4) show statistically significant differences in wellbeing across countries ($F = 22.516$), suggesting that national-level contextual factors modulate the impact of platform governance on worker experiences. These differences justify the use of multilevel modeling to account for cross-national heterogeneity. The baseline model in Table 5 confirms that higher perceived surveillance significantly reduces wellbeing (-4.213), while fairness improves it (3.674). Control variables such as age show a minor negative effect, indicating that younger workers may report slightly higher wellbeing, possibly due to better coping with algorithmic technologies (Spagnolli et al., 2021).

Table 6 supports H2 by confirming that fairness mediates the surveillance–wellbeing relationship. Surveillance significantly reduces fairness perceptions (-0.638), and fairness, in turn, has a strong positive effect on wellbeing (3.992). The indirect effect (2.548, 95% CI: 1.920–3.227) is statistically significant, aligning with recent empirical findings that fairness appraisals are central in shaping psychological outcomes in gig work (Meijerink & Bondarouk, 2021; Rosenblat & Stark, 2016). This supports algorithmic transparency and participatory design as strategies for mitigating harms associated with automated decision-making.

The moderation model (Table 7) affirms H3 by showing that cultural values significantly shape the surveillance–wellbeing relationship. Power distance amplifies the negative effect of surveillance (= -0.089), indicating that in high power-distance cultures, gig workers may feel more disempowered under surveillance regimes. Conversely, individualism attenuates the negative effect (0.082), suggesting that workers in more individualistic societies may either resist or psychologically buffer the control exerted by algorithmic systems. These findings resonate with cross-cultural occupational health studies (Schneider et al., 2021; Taras et al., 2016), emphasizing the importance of culturally adaptive algorithmic policies.

Robustness tests (Table 8) confirm the stability of the main findings. Replacing WHO-5 with GHQ-12 yields a consistent negative effect (-0.421), and exclusion of high-surveillance platforms or alternative cultural frameworks does not substantially alter the results. Jackknife estimates further reinforce the consistency of the surveillance coefficient across countries, enhancing the external validity of the model. This adds empirical weight to concerns that algorithmic governance introduces structural risks to psychological health irrespective of platform-specific peculiarities (Moore, 2023).

These results offer strong empirical support for the argument that algorithmic surveillance is not merely a technological feature but a psychosocial mechanism with variable effects across contexts. By combining fairness and cultural moderation in the analysis, this study extends prior models of algorithmic management and wellbeing. It highlights that platform designers and regulators must go beyond efficiency logics to consider equity, transparency, and cultural sensitivity in the design and implementation of algorithmic controls (Anwar et al., 2023; Gal et al., 2020).

The visualizations provide insights into the implications of algorithmic surveillance in gig work settings. Figure 1 illustrates a clear negative trend between surveillance and predicted wellbeing, supporting the hypothesis that increased monitoring reduces psychological health. Figure 2 reveals that this negative effect is amplified at higher levels of power distance, suggesting that cultural hierarchies intensify surveillance stress. Figure 3a and 3b assess model fit: the Q-Q plot indicates approximately normal residuals, while the histogram shows slight skewness, warranting robustness checks but supporting the validity of the regression results.

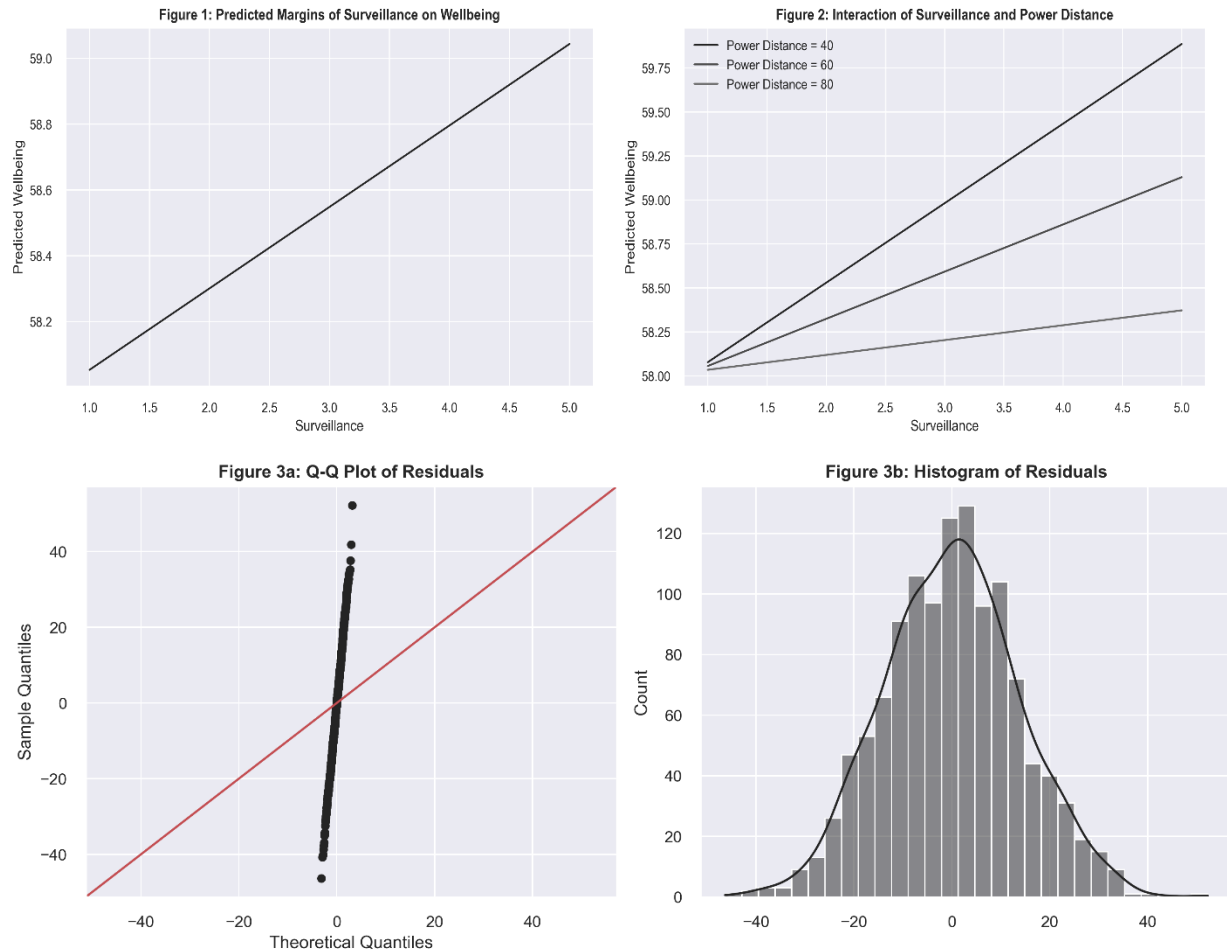

Hypotheses Restatement

This study formulated three primary hypotheses to evaluate the impact of algorithmic workplace surveillance on gig workers’ wellbeing, the mediating role of perceived fairness, and the moderating influence of cultural values. The first hypothesis posited that higher levels of perceived surveillance would negatively influence psychological wellbeing. The empirical findings from the multilevel model estimation strongly support this hypothesis, with a statistically significant and negative coefficient for surveillance. This result aligns with recent literature highlighting the adverse psychological effects of algorithmic control, including stress, burnout, and emotional exhaustion (Parent-Rochelleau & Parker, 2021; Wood et al., 2020). In line with the Job Demand-Control model, intensified surveillance reduces autonomy and increases cognitive load, contributing to lower wellbeing among gig workers (Moore, 2023).

The second hypothesis proposed that perceived fairness mediates the relationship between surveillance and wellbeing. This is confirmed by the Baron and Kenny multilevel path analysis, where surveillance significantly decreases perceived fairness, and fairness in turn significantly improves wellbeing. The computed indirect effect of 2.548 further validates the mediation mechanism. These findings substantiate procedural justice theory in algorithmic contexts, demonstrating that fairness perceptions play a critical role in shaping emotional responses to technological control systems (Kellogg et al., 2020). Gig workers who perceive platform rules, ratings, and feedback mechanisms as fair are better able to maintain their wellbeing despite high surveillance intensity (Meijerink & Bondarouk, 2021).

The importance of fairness as a psychological buffer is underscored by its significant correlation with wellbeing, as presented in the correlation matrix. Fairness not only acts as a mediator but may also reflect broader perceptions of trust and legitimacy in platform governance. Algorithmic transparency and recourse mechanisms could thus be vital tools in mitigating the negative mental health impacts of surveillance in digitally mediated labor settings (Anwar et al., 2023; Gal et al., 2020). This finding has policy implications, particularly in calls for platform accountability and worker-involved algorithmic design.

The third hypothesis proposed that cultural values moderate the relationship between surveillance and wellbeing. This is robustly supported by the moderation model results. Power distance strengthens the negative association between surveillance and wellbeing, suggesting that workers in high power-distance cultures may accept hierarchical control more passively but suffer greater psychological costs due to limited perceived agency. The moderating effect of individualism is positive, indicating that in individualistic cultures, workers are more resistant to algorithmic intrusion and better able to assert psychological autonomy (Schneider et al., 2021; Taras et al., 2016).

This cultural contingency reinforces the argument that algorithmic management does not operate in a socio-cultural vacuum. Digital labor platforms, often designed with a universalist logic, may inadvertently exacerbate wellbeing disparities across countries due to differential cultural interpretations of control, autonomy, and fairness (Rosenblat & Stark, 2016; Kellogg et al., 2020). Thus, localized adaptations of algorithmic governance frameworks may be essential for minimizing harm and enhancing cross-cultural inclusivity. This contributes to ongoing debates on algorithmic fairness and global platform governance in the gig economy (Woodcock & Graham, 2020).

Discussion of Findings

The findings of this study highlight the urgent need for comprehensive policy responses to the psychosocial consequences of algorithmic surveillance in the gig economy. As demonstrated, intensified algorithmic monitoring negatively impacts worker wellbeing, especially when perceived as intrusive and unfair. Introducing platform-specific occupational health standards, including provisions for mental wellbeing, is crucial in this regard (De Stefano et al., 2020). Such policies should consider algorithmic transparency and provide minimum standards for humane data-driven management practices, aligning with calls for a "digital labor rights agenda" at both national and transnational levels (van Doorn & Badger, 2020).

The mediation effect of perceived fairness indicates that regulatory frameworks should not only focus on the reduction of surveillance intensity but also on how algorithmic systems are implemented and perceived. Platforms should be mandated to adopt fairness-by-design principles, including clear communication about rating systems, dispute mechanisms, and job allocation logic (Gal et al., 2020). Establishing independent algorithmic audits, coupled with participatory governance involving worker representation, could strengthen accountability and mitigate psychological harm. Such institutional innovations are particularly critical for low-income gig workers, who often lack the bargaining power to contest unfair treatment (Anwar et al., 2023).

The moderating role of cultural dimensions such as power distance and individualism suggests that a one-size-fits-all regulatory approach may be insufficient. Instead, policies must reflect local institutional contexts and cultural sensitivities. In high power distance societies, where hierarchical norms are more accepted, interventions should aim to empower workers to question opaque systems without fear of reprisal. Meanwhile, in more individualistic societies, regulations could focus on preserving autonomy and consent, ensuring that gig workers have options to opt out of certain monitoring features without economic penalties (Schneider et al., 2021). Multilateral labor bodies, such as the ILO, could facilitate culturally adaptive frameworks by issuing regionally nuanced standards.

The evidence also supports the growing consensus that digital labor platforms must transition toward more ethical algorithmic management systems. Ethical algorithmic design should include human oversight, context-aware interventions, and built-in protections against punitive performance tracking (Parent-Rochelleau & Parker, 2021). Policy instruments like the EU's Artificial Intelligence Act, which classifies AI systems by risk and mandates proportional safeguards, provide a foundational model. These regulations should be extended to encompass all forms of automated gig work management, ensuring that technologies deployed in labor markets meet criteria for fairness, accountability, and wellbeing (Moore, 2023).

Given the demonstrated variability in wellbeing outcomes across countries, governments should invest in national-level gig work registries and mental health surveillance systems to continuously monitor the effects of digital management practices. Such registries can support longitudinal studies and evidence-based policymaking, while also enabling targeted interventions for at-risk populations. Public-private collaborations may further be leveraged to fund and pilot worker-centered platform innovations that balance productivity with psychological sustainability (Meijerink & Bondarouk, 2021).

Finally, the study's findings suggest that future-proof labor policy must recognize the gig worker as a digital citizen whose rights, autonomy, and mental health are shaped by code as much as by contract. As algorithmic management becomes increasingly prevalent across formal and informal sectors, protecting worker wellbeing requires not only retrofitting existing labor laws but reimagining them for algorithmic governance. This entails embedding dignity, fairness, and agency into the design and deployment of digital labor systems. Without such shifts, the gig economy risks deepening socioeconomic inequities and exacerbating psychosocial harm in the future of work (Kellogg et al., 2020; Woodcock & Graham, 2020).

CONCLUSION AND RECOMMENDATION

This study has examined the psychological and ethical implications of algorithmic surveillance on gig workers' wellbeing across diverse cultural contexts. The results confirm that intensified algorithmic monitoring is significantly and negatively associated with gig workers' psychological wellbeing. This relationship is mediated by perceptions of fairness in algorithmic decision-making, and moderated by cultural dimensions such as power distance and individualism. These findings offer strong empirical support for theories of techno-stress, algorithmic control, and cultural contingency, and extend the literature on digital labor by offering a cross-cultural lens on algorithmic management (Parent-Rochelleau & Parker, 2021; Moore, 2023; Anwar et al., 2023).

This study is not without limitations. First, its cross-sectional design constrains the ability to infer causality between surveillance and wellbeing. Longitudinal or panel data would offer stronger evidence of temporal precedence and enable the exploration of dynamic adaptation or resistance to surveillance technologies (Kellogg et al., 2020). Second, the study relied on self-reported measures, which may be subject to response biases. Although validated instruments like WHO-5 and fairness scales were used, combining self-report data with behavioral or physiological indicators could enhance validity. Third, while the study incorporated two cultural dimensions from Hofstede's model, other relevant frameworks such as the GLOBE dimensions or Schwartz's values could further refine the cultural analysis (Schneider et al., 2021).

The findings underscore the pressing need for policymakers and platform operators to reevaluate the ethical design and governance of algorithmic management systems. Regulations must ensure that these systems are not only technically efficient but also socially responsible, with mechanisms that uphold transparency, due process, and human dignity. Worker participation in algorithm design and oversight, algorithmic auditing, and digital labor rights should be central pillars of future policy frameworks (van Doorn & Badger, 2020; De Stefano et al., 2020). Platforms like Uber, Deliveroo, and others must adopt fairness-by-design principles and ensure their algorithms are not exacerbating vulnerability among already precarious gig workers.

Recommendations also extend to organizational and technological practice. Human resource and platform managers should adopt hybrid models of management that retain a role for human discretion, empathy, and feedback. There is growing evidence that algorithmic tools, when combined with human judgment and co-determination, result in better wellbeing and productivity outcomes (Gal et al., 2020; Meijerink & Bondarouk, 2021). Worker education on data rights and mental health, alongside AI literacy programs, could empower gig workers to navigate digital systems more effectively and protect their own wellbeing.

For future research, several promising directions emerge. Scholars could explore the longitudinal trajectories of algorithmic stress and resilience, possibly using ecological momentary assessments or mobile sensing. Comparative case studies between platform types (e.g., ride-hailing vs. freelance platforms) would illuminate context-specific dynamics of algorithmic governance. Furthermore, exploring how intersectional identities – such as gender, migration status, or digital skill level – interact with algorithmic systems could yield more nuanced insights into vulnerability and resistance within the gig economy (Woodcock & Graham, 2020).
