## DETERMINANTS OF BANKS' LIQUIDITY MANAGEMENT IN SUB-SAHARAN AFRICA

### **Abstract**

*Liquidity management remains one of the most critical aspects of banking operations, as it directly influences financial stability, credit intermediation, and the resilience of the financial system. This study examines the determinants of liquidity management among commercial banks in Sub-Saharan Africa. Adopting a quantitative explanatory research design, the study utilizes balanced panel data from deposit money banks purposively selected based on continuous operation over the period 2010–2022. The analysis employed panel least squares regression and the results reveal that government securities exert a positive and statistically significant effect on reserve requirements (0.000;  $p < 0.05$ ), underscoring their dual role as both yield-bearing assets and liquidity buffers. Vault cash holdings (–0.000;  $p < 0.05$ ) and interbank credit (–0.000;  $p < 0.05$ ) exhibit negative associations with reserve requirements, highlighting substitution effects and risk–return trade-offs in banks' liquidity management decisions. Interbank lending shows a positive but weaker association ( $p < 0.10$ ), reflecting its modest influence on regulatory liquidity buffers. The sensitivity model confirms liquidity persistence, with the lagged reserve requirement ratio remaining positive and significant ( $\beta = 0.374$ ;  $p = 0.012$ ), indicating path-dependent adjustment behavior among banks. Policy implications suggest the need for gradual reserve requirement adjustments, deepening of government securities markets, tighter regulatory oversight of interbank exposures, and enhanced fiscal–monetary coordination to balance financial stability with credit growth. In conclusion, the study recommends a balanced liquidity regulation framework that integrates market-based instruments with prudential supervision, ensuring resilience of the banking sector. These findings contribute to the literature on liquidity management by providing context-specific, statistically grounded insights into the Nigerian banking sector, with broader relevance for other emerging economies.*

### **INTRODUCTION**

Liquidity management remains one of the most critical aspects of banking operations, as it directly influences financial stability, credit intermediation, and the resilience of the financial system. Banks must strike a delicate balance between maintaining sufficient liquidity to meet short-term obligations and optimizing asset allocation to maximize profitability. In emerging economies such as Nigeria, where financial markets are less developed and macroeconomic volatility is frequent, the management of liquidity assumes even greater significance. Recent studies have emphasized that inadequate liquidity management was one of the major triggers of systemic banking crises, leading to insolvency, reduced lending capacity, and erosion of public confidence (Bonner et al., 2022; Kassim & Majid, 2020). This concern has been reinforced by recent

global shocks, including the COVID-19 pandemic, which exposed vulnerabilities in banks' liquidity buffers and highlighted the central role of regulatory liquidity instruments in crisis mitigation (Abboud et al., 2021).

The Nigerian banking sector faces unique liquidity challenges arising from fiscal dominance, volatile capital flows, and the central role of government securities in monetary operations. As the Central Bank of Nigeria (CBN) frequently employs reserve requirements as a liquidity-mopping tool, banks are compelled to maintain substantial balances that often crowd out lending to the private sector (Noko & Ogheneovo, 2023). Furthermore, persistent inflationary pressures and exchange rate instability exert additional pressure on liquidity management strategies. Consequently, understanding the determinants of liquidity management is not only vital for regulatory policy but also for the stability of Nigeria's financial system and its capacity to foster economic growth (Imoleayo et al., 2021; Ojo & Adebayo, 2022). Despite the importance of these issues, empirical evidence on how specific balance-sheet components jointly shape reserve requirement behavior in Nigeria remains limited and fragmented.

Against this background, the first objective of this study is to examine the influence of vault cash holdings on banks' liquidity management, proxied by the reserve requirement ratio. Vault cash represents an immediate but non-interest-bearing form of liquidity. While it allows banks to meet withdrawal demands, excessive holdings may reflect inefficiency by tying down idle resources. Recent research indicates that banks in emerging economies tend to over-allocate to vault cash during periods of macroeconomic uncertainty, which can reduce their capacity to extend credit (Berrospide, 2021; Ngalawa & Viegli, 2021). By analyzing the role of vault cash in Nigerian banks' reserve allocations, this study sheds light on the trade-offs between precautionary liquidity and profitability. This focus responds to calls in the literature for country-specific evidence on internal liquidity buffers in emerging banking systems (Yitayaw, 2021).

The second objective is to investigate the role of government securities in shaping liquidity management. Government securities are widely regarded as the safest and most liquid assets, and in Nigeria they serve as a key instrument for both monetary policy implementation and fiscal financing. Their role as dual-purpose assets, providing returns and fulfilling liquidity requirements, has been highlighted in both theoretical and empirical literature (Kassim & Majid, 2020; Obida & Okoye, 2023). By evaluating the relationship between securities holdings and reserve requirements, this study provides insights into whether securities act as substitutes or complements in banks' liquidity strategies. This issue is particularly relevant in fiscally dominant environments, where heavy domestic borrowing may alter banks' liquidity incentives and crowd out private credit (Noko & Ogheneovo, 2023).

The third objective is to assess the effects of interbank lending and interbank credit on liquidity management. The interbank market facilitates short-term liquidity redistribution among banks, enabling institutions with surplus funds to support those facing temporary shortfalls. However, reliance on interbank credit also introduces counterparty and systemic risks that may undermine overall liquidity stability (Acharya & Merrouche, 2013; Bonner et al., 2022). In the Nigerian context, where interbank markets are less developed compared to advanced economies, examining their role in liquidity management provides valuable policy guidance on financial deepening and risk containment. This study therefore contributes to the limited empirical

evidence on how interbank exposures interact with regulatory liquidity requirements in Sub-Saharan Africa.

Finally, the fourth objective is to evaluate the dynamic persistence of liquidity management, as proxied by the lagged reserve requirement ratio. Empirical evidence suggests that banks' liquidity strategies are often path-dependent, with past allocations shaping current decisions (Berrospide, 2021; Osho & Adeoye, 2024). Understanding this persistence has crucial policy implications, particularly for the design and implementation of reserve requirement policies by the CBN. By incorporating this dynamic dimension, the study captures the structural inertia that characterizes liquidity management in Nigeria's banking system. Collectively, these objectives provide a comprehensive analysis of the determinants of liquidity management, bridging theoretical insights with empirical realities in an emerging market context. Overall, the study contributes to the literature by jointly examining internal liquidity buffers, market-based instruments, and dynamic adjustment behavior within a unified empirical framework, thereby extending existing evidence on liquidity management in emerging economies.

### LITERATURE REVIEW

Bank liquidity research has concentrated on three connected themes: (1) the composition and drivers of banks' liquid assets (reserve holdings, vault cash, government securities, and other HQLA), (2) the consequences of liquidity choices for lending, profitability and systemic risk, and (3) how regulation and monetary policy (reserve requirements, LCR, tiering, QE, and emergency facilities) reshape banks' liquidity management. Across jurisdictions, empirical studies show that banks actively manage a portfolio of liquid instruments and that policy changes that alter the relative costs or returns of specific instruments lead to predictable portfolio shifts. For example, the ECB "tiering" experiment and follow-up analyses reveal that lowering the implicit cost of reserves for some banks caused treated banks to increase reserve holdings while reducing holdings of marketable securities and interbank lending, indicating substitution across liquidity instruments (Baldo et al., ECB WP 2732, 2022). Similarly, research on U.S. banks' HQLA management shows that LCR and regulatory constraints materially affected asset composition after 2015 (St. Louis Fed review, 2019).

A second robust finding is the importance of the macrofinancial environment and bank business models in shaping liquidity behaviours. Cross-country panel studies and country case studies (China, Vietnam, South Africa, Nigeria, Ethiopia, India and others) document that bank size, business model (universal vs retail; state vs private), capitalization, and funding mix condition both levels and responses of liquidity buffers to shocks (Tran, 2024; Davydov, Vähämaa & Yasar, 2021; Vuong et al., 2023). Larger and better-capitalized banks tend to hold different mixes of high-quality liquid assets and use market liquidity resources more intensively, whereas smaller banks rely more on vault cash and interbank markets where available (Davydov et al., 2021; Vuong, 2023). Studies from emerging markets emphasize that underdeveloped government bond markets and shallow interbank markets constrain substitution possibilities and raise the cost of achieving regulatory liquidity ratios (Yitayaw, 2021; Noko & Ogheneovo, 2023).

A third cluster of results concerns the real-economy consequences of liquidity rules. Empirical evaluations of reserve-requirement changes and liquidity regulation (including the removal of reserve requirements during the COVID-19 shock in the U.S.) find that relaxations of binding reserve constraints can support lending in stressed times, while abrupt tightening can reduce

credit supply (Koch & Islam, SSRN; Abboud et al., 2021; Liu, FRBSF, 2023). At the same time, several studies caution that reserve requirements are a blunt tool: they affect not only banks' reserve holdings but also deposit behaviour, interest rates, and banks' risk choices, with potential crowding-out effects when fiscal borrowing absorbs marketable securities used as HQLA (Afanasyeva, 2020; Bonner et al., 2022). Country studies show mixed welfare implications: in some settings reserve hikes shore up stability but at short-term credit cost; in others they create incentives for regulatory arbitrage.

Several papers specifically explore liquidity creation and systemic risk: liquidity creation (the banking function of transforming liquid deposits into illiquid assets) is empirically linked both to growth and to fragility. Davydov et al. (2021) document that liquidity creation can reduce some measures of systemic tail risk at the bank level in US sample data, while other work finds cases where aggressive liquidity creation is associated with higher loan losses or risk-taking in certain contexts (Tran, 2016; Vuong et al., 2023). This heterogeneity suggests a contextual dependence: whether liquidity creation is stabilizing or destabilizing hinges on regulation, market access, capital cushions, and macroeconomic conditions. Cross-country panel work and firm-level studies show that managerial ability, competition, and funding diversification moderate the liquidity-risk relationship (Tran, 2024; Andreou et al., 2016).

The COVID-19 episode produced a rich set of quasi-experimental evidence on how sudden funding shocks and policy responses affect liquidity management. Studies of central bank interventions during the pandemic demonstrate that emergency facilities, asset purchases and temporary reserve changes materially reshaped banks' balance sheets – sometimes supporting lending, sometimes crowding in deposits into safer forms (Abboud et al., 2021; Darst, 2025; O'Donnell et al., 2024). Researchers also document bank heterogeneity in responses: some banks hoarded liquidity despite central-bank backstops, reflecting precautionary motives and risk management conservatism, while others used central-bank facilities to maintain lending. These micro-heterogeneities reveal the limits of one-size-fits-all policy prescriptions and argue for targeted or tiered instruments.

Methodologically, the empirical literature is diverse: papers employ panel fixed-effects and random-effects regressions, dynamic panels (GMM, LSDVC), difference-in-differences exploiting policy shocks (ECB tiering, Fed reserve changes), event studies (policy announcement windows), and structural VARs to capture macro feedbacks. The use of high-frequency data in central-bank studies (daily/weekly) allows precise identification of portfolio shifts following policy announcements (Baldo et al., 2022; Darst, 2025). Country studies commonly use bank-level panel regressions with lags to capture persistence and path dependence (Berrospide, 2021; Yitayaw, 2021). Several studies emphasize the need to control for endogeneity and employ instrumentation (policy dummies, regulatory thresholds) or dynamic panel estimators to address bias (Abboud et al., 2021; Davydov et al., 2021).

A recurring policy lesson across the literature is that market structure and instrument design matter. Deep, liquid government bond markets and well-functioning interbank markets increase banks' ability to meet regulatory liquidity ratios without sacrificing lending; conversely, thin markets force banks to hold larger non-yielding vault cash or central-bank reserves (Kassim & Majid, 2020; Noko & Ogheneovo, 2023). Empirical comparisons between advanced and emerging markets indicate that the same regulatory prescriptions (LCR, reserve hikes) can have divergent

effects depending on market depth and the prevalence of foreign-currency or informal funding. Thus, the literature advocates calibrated, context-sensitive regulation, for instance, tiered reserve schemes or targeted liquidity windows to address idiosyncratic stress without stifling credit.

Finally, the empirical corpus highlights important gaps and future directions. Several recent papers call for more firm-level and transaction-level datasets to separate the extensive margin (entry/exit of borrowers) from the intensive margin (loan size) in the lending response to liquidity policy (Berrospide, 2021; Darst, 2025). Cross-country work suggests fruitful comparisons but also warns against overgeneralisation: country-specific institutional details (remuneration of reserves, market conventions for invoicing, availability of swap lines) shape outcomes. There is also growing interest in the interaction of liquidity policy with macroprudential buffers and fiscal policy (Liu, 2023; Afanasyeva, 2020). Taken together, the empirical evidence provides a rich, nuanced base for the Nigeria-focused results reported in this study: government securities, interbank markets and vault cash do not act in isolation, and regulatory design and market context are decisive for the direction and magnitude of policy effects.

## METHODOLOGY

### Theoretical Framework.

The theoretical basis for analyzing the determinants of liquidity management among commercial banks rests primarily on the Liquidity Preference Theory, the Risk-Return Trade-Off, and the Diamond-Dybvig model of bank intermediation. Each provides a distinct yet complementary explanation of why liquidity is central to banking operations and how it interacts with profitability, stability, and systemic risk.

The Liquidity Preference Theory, originally formulated by Keynes, argues that economic agents prefer to hold liquid assets because they minimize exposure to uncertainty and unexpected shocks. In the banking context, this translates into the necessity of holding adequate cash reserves to meet withdrawal demands and regulatory requirements. The liquidity demand function may be expressed as:

$$L_t = f(Y_t, i_t) = \lambda_0 + \lambda_1 Y_t - \lambda_2 i_t + v_t \quad (1)$$

where  $L_t$  is the demand for liquidity at time  $t$ ,  $Y_t$  is the level of income,  $i_t$  is the interest rate, and  $v_t$  is a random disturbance term. A positive relationship is expected between liquidity demand and income, while a negative relationship exists with interest rates, reflecting the opportunity cost of holding idle reserves (Keynes, 1936; Hicks, 1937).

The Risk-Return Trade-Off Theory extends this framework by emphasizing that banks must balance the trade-off between holding liquid assets, which ensure safety but yield low returns, and investing in illiquid assets, which generate higher returns but expose the bank to liquidity risk. A simplified representation of this trade-off can be captured through the expected utility maximization function:

$$U = \pi(A) - \theta \sigma^2(A) \quad (2)$$

where  $U$  is the bank's expected utility,  $\pi(A)$  is the expected return on asset allocation  $A$ ,  $\sigma^2(A)$  denotes the variance of returns as a proxy for risk, and  $\theta$  reflects the degree of risk aversion. Optimal liquidity management requires a portfolio allocation that maximizes  $U$ , given the trade-off between return and liquidity risk (Markowitz, 1952; Baltensperger, 1980).

A more explicit theoretical underpinning is provided by the Diamond-Dybvig model of banking, which formalizes how banks transform short-term liabilities into long-term assets, thereby creating liquidity but also exposing themselves to potential runs. In their model, depositors face

uncertainty regarding their liquidity needs: some are “early consumers” while others are “late consumers.” The bank’s role is to allocate resources efficiently between liquid reserves and illiquid investments. The payoff function of depositors can be expressed as:

$$c_1 \leq R \cdot \frac{D}{\phi} \quad (3)$$

$$c_2 \geq (1 - R) \cdot \frac{D}{1 - \phi} \quad (4)$$

where  $c_1$  and  $c_2$  represent consumption by early and late consumers,  $D$  denotes total deposits,  $R$  is the proportion allocated to liquid reserves, and  $\phi$  is the fraction of early consumers. When  $R$  is insufficient, early withdrawals can trigger bank runs, justifying the need for reserve requirements and central bank interventions (Diamond & Dybvig, 1983).

Holmström and Tirole (1998) extend this argument by incorporating liquidity shocks and moral hazard into the analysis. They argue that banks must hold both private liquidity buffers and rely on public liquidity provision (e.g., lender of last resort facilities). The equilibrium liquidity demand can be formalized as:

$$L^* = \gamma P + (1 - \gamma)B \quad (5)$$

where  $L^*$  is the optimal liquidity buffer,  $P$  denotes private liquidity,  $B$  central bank liquidity, and  $\gamma$  the weight assigned to self-insurance by the bank. In equilibrium, banks balance private buffers with the expectation of external support.

Together, these theoretical perspectives suggest that liquidity management is determined by a set of interrelated factors: the precautionary motive for liquidity holding (Keynesian theory), the trade-off between risk and return (portfolio theory), and the systemic risks associated with maturity transformation (Diamond–Dybvig framework). In the Nigerian context, the reserve requirement ratio serves as a regulatory mechanism that ensures banks hold sufficient liquidity, aligning with these theoretical insights.

## Models and Methods

This study investigates the determinants of liquidity management among commercial banks in Nigeria using panel data spanning the period 2010–2022. The sample comprises six cross-sectional units representing licensed deposit money banks operating consistently throughout the study window. Data were collected from the Central Bank of Nigeria (CBN) Statistical Bulletin, Nigerian Deposit Insurance Corporation (NDIC) annual reports, and the World Bank’s World Development Indicators. The dependent variable is the Reserve Requirement Ratio (RRR), which serves as a proxy for liquidity management. Four explanatory variables were included: Vault Cash Holdings (VCH), Government Securities (GSE), Interbank Lending (IBL), and Interbank Credit (IBC). These variables were selected based on their theoretical relevance and empirical validation in previous studies on bank liquidity management (Mohammed et al., 2014; Diamond & Dybvig, 1983). Specifically, VCH captures internal liquidity buffers, GSE reflects market-based liquid assets widely used for regulatory compliance, while IBL and IBC represent interbank market activities that facilitate short-term liquidity redistribution. Their inclusion allows the model to reflect both balance-sheet and market-driven dimensions of liquidity management within the Nigerian banking system.

The use of panel data allows the model to capture both the time-series dynamics and cross-sectional heterogeneity of banks, thereby improving efficiency in parameter estimation and minimizing risks of omitted variable bias (Baltagi, 2021). The empirical specification is based on a modification of the model proposed by Mohammed et al. (2014). The justification for this

modification lies in contextual and regulatory differences between the original study environment and the Nigerian banking system. While Mohammed et al. (2014) modeled bank liquidity using a broader liquidity ratio, this study substitutes the Reserve Requirement Ratio as the dependent variable to better reflect Nigeria's regulatory framework, where reserve requirements are a central monetary policy instrument actively used by the Central Bank of Nigeria to manage systemic liquidity. Moreover, the inclusion of interbank lending and interbank credit as separate regressors extends the original model by explicitly accounting for interbank market dynamics, which have become increasingly important in Nigeria following post-crisis regulatory reforms. The baseline model is presented as:

$$RRR_{it} = \beta_0 + \beta_1 VCH_{it} + \beta_2 GSE_{it} + \beta_3 IBL_{it} + \beta_4 IBC_{it} + \varepsilon_{it} \quad (6)$$

where  $RRR_{it}$  denotes the reserve requirement ratio for bank  $i$  in period  $t$ ,  $VCH_{it}$  represents vault cash holdings,  $GSE_{it}$  government securities,  $IBL_{it}$  interbank lending, and  $IBC_{it}$  interbank credit.  $\varepsilon_{it}$  is the idiosyncratic error term assumed to be independently and identically distributed.

To test the robustness of results, a sensitivity specification was estimated by incorporating lagged effects of liquidity variables to capture potential persistence in liquidity management practices. The sensitivity model is given by:

$$RRR_{it} = \alpha_0 + \alpha_1 VCH_{it} + \alpha_2 GSE_{it} + \alpha_3 IBL_{it} + \alpha_4 IBC_{it} + \alpha_5 RRR_{it-1} + u_{it} \quad (7)$$

where  $RRR_{it-1}$  is the lagged dependent variable capturing dynamic adjustments in liquidity positions, and  $u_{it}$  is the disturbance term.

The study employs the panel least squares (PLS) regression technique, which is particularly suited to models involving cross-sectional and time-series dimensions. The PLS framework offers efficient estimators under the assumption of homoscedasticity and absence of serial correlation. Both fixed effects and random effects specifications were initially considered, and the Hausman test was employed to determine the more appropriate model structure (Wooldridge, 2010). Robustness checks were conducted using heteroskedasticity-consistent standard errors and the inclusion of lagged dependent variables (Equation 2) to account for persistence in liquidity management. Additionally, multicollinearity tests were carried out using variance inflation factors (VIF), while model stability was examined through serial correlation and Durbin–Watson statistics.

## RESULTS AND DISCUSSION

The estimation results presented in Table 2 provide the baseline regression outcomes for the determinants of liquidity management among Nigerian commercial banks, proxied by the Reserve Requirement Ratio (RRR). The model reveals an  $R^2$  of 0.703, suggesting that approximately 70 percent of the variation in reserve requirements can be explained by the included independent variables, including Vault Cash Holdings (VCH), Government Securities (GSE), Interbank Lending (IBL), and Interbank Credit (IBC). This relatively high explanatory power indicates that the chosen determinants are relevant and capture significant aspects of banks' liquidity behavior. The Durbin-Watson statistic of 1.899 is close to the benchmark value of 2, signifying the absence of serial correlation and supporting the reliability of the estimates.

Examining the coefficients, VCH displays a negative and statistically significant relationship with RRR, although the magnitude of the coefficient is close to zero. This result implies that as banks hold more cash in their vaults, their reliance on mandatory reserve balances at the central bank diminishes. This finding is consistent with the liquidity preference theory, which posits that banks manage their liquid assets by balancing internal holdings against regulatory requirements (Keynes, 1936; Baltensperger, 1980). Recent empirical evidence from African banking markets suggests that higher levels of vault cash are often maintained as precautionary liquidity buffers, thereby reducing the sensitivity to regulatory reserves (Ngalawa & Viegi, 2021).

Government securities (GSE) emerge as positively and significantly associated with RRR, supporting the hypothesis that banks holding higher volumes of treasury instruments simultaneously comply with regulatory liquidity requirements. The positive coefficient indicates complementarity rather than substitution between liquid asset investments and reserve balances. This reflects the dual role of treasury securities as both a yield-generating investment and a liquidity buffer, particularly in economies where government securities are deeply integrated into monetary policy operations (Kassim & Majid, 2020). In Nigeria's case, treasury bills function as an essential channel for sterilization and liquidity absorption, reinforcing banks' need to maintain reserves in tandem with securities holdings.

The coefficient for interbank lending (IBL) is positive but statistically weaker at the conventional levels, suggesting a modest linkage between participation in the interbank market and reserve requirements. Banks more active in interbank lending are likely to face higher liquidity management obligations, reflecting their increased exposure to settlement risk and payment flows. This resonates with the interbank market literature, which emphasizes that short-term lending activities create reciprocal obligations that may necessitate larger regulatory buffers (Acharya & Merrouche, 2013). Although the effect is weaker, the positive association underscores the systemic importance of the interbank market in shaping liquidity allocation across Nigerian banks.

By contrast, interbank credit (IBC) demonstrates a negative and statistically significant coefficient, aligning with the interpretation that banks extending substantial credit to other institutions may offset their reserve needs by diversifying liquidity exposures. This outcome reflects the risk-return trade-off in liquidity management: extending interbank credit may improve returns but reduces the volume of funds available for mandatory reserves, thereby exposing banks to liquidity risk (Bonner et al., 2022). The implication is that Nigerian banks adopting aggressive

credit extension strategies in the interbank market may lower their compliance with regulatory buffers, a finding with policy significance for liquidity supervision.

The sensitivity analysis in Table 3 extends the baseline model by including a lagged dependent variable, RRR(-1), which captures dynamic persistence in banks' liquidity behavior. The lagged coefficient of 0.374 is positive and statistically significant at the 5 percent level, indicating that past reserve requirements significantly influence current levels. This persistence suggests that liquidity management is path-dependent, with banks adjusting their reserves incrementally rather than making abrupt shifts. Such inertia is well-documented in banking studies, where institutions rely on historical liquidity positions to guide current allocations (Berrospide, 2021). The implication for regulators is that liquidity shocks or policy changes are likely to have gradual, rather than immediate, effects on reserve compliance.

Comparing explanatory power, the sensitivity model yields an R<sup>2</sup> of 0.742, slightly higher than the baseline, indicating improved model fit. The inclusion of the lagged term strengthens the case for dynamic specifications in analyzing liquidity determinants. Notably, the significance of GSE persists, while VCH and IBC retain their respective signs but with slightly attenuated statistical strength. This reinforces the interpretation that government securities are a robust determinant of liquidity management in Nigeria, consistent with evidence from other emerging economies where public debt instruments serve as both regulatory and market liquidity anchors (Noko & Ogheneovo, 2023).

Robustness and diagnostic tests reported in Table 4 further validate the integrity of the results. The mean Variance Inflation Factor (VIF) of 2.137 confirms the absence of multicollinearity, ensuring that the coefficients are not biased by redundant explanatory variables. The Breusch-Pagan test yields a probability of 0.145, leading to the acceptance of the null hypothesis of homoscedasticity, thus ruling out heteroskedasticity problems. The Ramsey RESET test also indicates correct model specification, while the CUSUM stability test suggests the absence of structural breaks at the 5 percent level. These outcomes jointly enhance confidence in the robustness of the findings, affirming that the estimated relationships are both statistically and economically meaningful.

Finally, the Durbin-Watson statistic, replicated in Table 4, confirms the absence of serial correlation, a critical requirement for the validity of panel least squares estimates. Taken together, the diagnostic results demonstrate that the model is well-specified, stable, and reliable for policy inference. The findings, therefore, provide a strong empirical foundation for understanding how Nigerian commercial banks manage their liquidity through reserve requirements, with government securities emerging as a pivotal determinant and interbank exposures exerting nuanced effects.

### Discussion of Findings

The empirical findings of this study hold several critical implications for banking regulation and financial stability in Nigeria. The significant influence of government securities on reserve requirements underscores their dual role as both investment assets and regulatory liquidity buffers. This suggests that policymakers should continue to deepen the secondary market for government securities, thereby enhancing their liquidity profile and ensuring that banks can seamlessly adjust their reserve positions. A well-functioning securities market not only supports liquidity management but also strengthens the transmission of monetary policy, as securities holdings directly shape banks' reserve allocation decisions (Kassim & Majid, 2020).

The negative relationship between interbank credit and reserve requirements highlights the potential vulnerabilities associated with excessive reliance on interbank exposures. While interbank credit provides banks with an avenue to diversify earnings and optimize balance sheets, it may weaken liquidity buffers, leaving institutions more exposed to sudden funding shocks. Regulators, therefore, need to strengthen oversight of interbank transactions, ensuring that such exposures are prudently monitored within broader liquidity adequacy frameworks. The establishment of prudential limits on interbank exposures, aligned with Basel III liquidity coverage ratio requirements, would mitigate systemic risks while preserving market efficiency (Bonner et al., 2022).

The persistence effect captured by the lagged reserve requirement ratio further indicates that liquidity management is path-dependent, with banks adjusting gradually to changes in reserve obligations. This inertia suggests that abrupt changes in reserve policies may disrupt financial intermediation and induce short-term volatility. Consequently, the Central Bank of Nigeria (CBN) should adopt a gradualist approach when altering reserve requirement ratios, allowing banks adequate time to rebalance portfolios without compromising lending activities. Evidence from emerging markets demonstrates that gradual policy adjustments reduce adjustment costs and mitigate credit contractions, thereby preserving financial stability (Berrospide, 2021).

The significance of vault cash holdings also carries important policy lessons. Banks appear to substitute between cash-in-vault and central bank reserves, meaning that excessive vault holdings may lead to inefficiencies by tying up non-remunerated assets. To address this, the CBN could incentivize banks to optimize liquidity holdings by providing remunerated reserve facilities or liquidity-absorbing instruments. Such measures would align banks' liquidity management practices with broader monetary policy goals, enhancing the efficiency of liquidity allocation within the financial system (Noko & Ogheneovo, 2023).

Moreover, the results emphasize the necessity of integrating liquidity supervision with fiscal policy management. Since government securities strongly influence banks' reserve behavior, excessive fiscal reliance on domestic borrowing may inadvertently tighten liquidity conditions in the banking sector. This could crowd out private credit and impede growth objectives. A coordinated policy framework between fiscal and monetary authorities would therefore ensure that debt issuance strategies are consistent with banking sector liquidity needs, reducing the risk of financial disintermediation (Acharya & Merrouche, 2013).

Finally, the robustness of the model specification and diagnostic outcomes provides confidence that these findings can inform long-term regulatory strategy. The evidence suggests that Nigerian banks' liquidity management is shaped by both market-based instruments (securities, interbank credit) and regulatory factors (reserve requirements). Hence, a balanced approach to liquidity policy is necessary to foster resilience in Nigeria's financial system. This multi-dimensional strategy would ensure that liquidity risks are mitigated while preserving banks' ability to support credit intermediation and economic growth.

## CONCLUSION

This study examined the determinants of liquidity management among Nigerian commercial banks using the reserve requirement ratio as a proxy. The findings show that banks' liquidity positions

are shaped by a combination of internal buffers and market-based instruments. Government securities emerged as a robust and positive determinant of reserve balances, reflecting their dual function as yield-generating assets and regulatory liquidity buffers. In contrast, vault cash holdings and interbank credit exerted negative effects on reserve requirements, highlighting substitution effects and risk–return trade-offs in liquidity allocation. Interbank lending showed a weaker but positive association, suggesting a modest role of interbank activity in reserve management. The significance of the lagged reserve requirement ratio confirms that liquidity management is path-dependent, with banks adjusting gradually based on past positions rather than making abrupt changes. Robust diagnostic tests further validated the model, reinforcing the credibility of the results. Overall, the findings are consistent with established liquidity theories, emphasizing the central role of liquidity in banking stability.

The results underscore the need for a balanced and coordinated liquidity regulation framework in Nigeria. Policymakers should deepen the treasury securities market to enhance liquidity and strengthen monetary policy transmission, while carefully managing fiscal reliance on domestic borrowing to avoid crowding out private credit. The negative impact of interbank credit highlights the importance of closer regulatory oversight and the alignment of interbank exposure limits with Basel III liquidity standards to mitigate systemic risk. Evidence of substitution between vault cash and reserves suggests that introducing remunerated reserve facilities or efficient liquidity-absorbing instruments could improve liquidity allocation without weakening buffers. Moreover, the persistence of liquidity positions implies that the Central Bank should adopt a gradual approach to reserve requirement adjustments to minimize disruptions to credit supply. Future research could incorporate broader macroeconomic shocks to further enrich understanding of liquidity dynamics.
