



IMPACT OF GEOPOLITICAL CONFLICT AND CLIMATIC VARIABILITY ON GLOBAL FOOD SECURITY: EVIDENCE FROM POST RUSSIA-UKRAINE INVASION

Abstract

The intersection of climate change, geopolitical instability, and food security has emerged as a critical area of global concern. This study investigates the complex interplay between climate change and food security in the context of the Russia–Ukraine war, employing a quantitative econometric research design based on high-frequency weekly time-series data spanning April 2022 to February 2025. The sample consists of approximately 150 weekly observations, constructed using purposive sampling of post-invasion weeks to capture periods of heightened climatic and geopolitical stress. Utilizing an econometric approach grounded in the Environmental Kuznets Curve (EKC) framework, the study applies Autoregressive Distributed Lag (ARDL) bounds testing, complemented by robustness checks using Newey–West HAC standard errors, Vector Error Correction Models (VECM), and instrumental variable (IV-2SLS) estimation to address dynamic effects and potential endogeneity. The analysis reveals the presence of statistically significant non-linear (inverted U-shaped) relationships between temperature and food security, and U-shaped effects of precipitation, confirming EKC dynamics in the climate–food nexus. The findings demonstrate that climatic variability, exacerbated by the ongoing conflict, has significantly disrupted food availability and access in vulnerable regions. The findings imply that policy responses should prioritize climate-resilient agricultural innovation, strengthened institutional frameworks, and diversification of food supply chains to reduce vulnerability to external shocks. It is therefore recommended that policymakers integrate climate adaptation strategies with governance reforms and conflict-sensitive food security planning, particularly in food-import-dependent developing economies affected by global geopolitical instability.

INTRODUCTION

The intersection of climate change, geopolitical instability, and food security has emerged as a critical area of global concern. The Russia-Ukraine war, which began in early 2022, has aggravated existing vulnerabilities in global food systems, particularly in developing regions that are already grappling with the adverse impacts of climate variability. As the war disrupts key agricultural exports and inflates global commodity prices, it underscores the compounded risks climate change poses to food production and distribution (FAO, 2022; Laborde et al., 2022). In this context, assessing how climate change affects food security, particularly during such a conflict, becomes not only timely but essential for evidence-based policymaking and targeted resilience strategies.

Climate change is widely recognized as a primary threat to food security due to its influence on crop yields, livestock productivity, water availability, and land quality (Schlenker & Roberts, 2022). Rising temperatures, increased frequency of extreme weather events, and shifting precipitation patterns threaten to reduce agricultural output, particularly in regions dependent on rainfed agriculture (Gouel & Laborde, 2021). These effects are exacerbated by geopolitical crises such as the Russia-Ukraine war, which has disrupted grain exports from two of the world's largest wheat and sunflower producers, thereby intensifying price volatility and constraining global food supply chains (Espitia et al., 2022). Consequently, understanding the dynamic interplay between climatic variables and conflict-induced food insecurity is critical for designing responsive interventions.

The war has highlighted the structural fragility of global food systems. With both Russia and Ukraine accounting for a significant share of global wheat, maize, and fertilizer exports, their prolonged conflict has had cascading effects on food-importing countries in Africa, Asia, and the Middle East (World Bank, 2022). Moreover, the war has coincided with anomalous climatic conditions, such as heatwaves in South Asia and prolonged droughts in the Horn of Africa, amplifying the urgency to assess the environmental-economic feedback loops affecting food access and availability (Swinnen & McDermott, 2022). As such, food security challenges cannot be disentangled from climate variability and conflict, which together reinforce systemic risks in fragile agrarian economies.

In the face of these multifaceted threats, the adoption of adaptive agricultural strategies, such as improved irrigation systems, greenhouse farming, climate-resilient crop varieties, and agricultural insurance, has become imperative. These innovations offer practical means of buffering climate shocks while enhancing productivity and ensuring more stable food supplies (Tsan et al., 2021). The effectiveness of such strategies depends on contextualizing them within empirical frameworks that can quantify and disentangle the relative influence of climatic and conflict-related drivers of food insecurity. Thus, empirical modeling, particularly within the Environmental Kuznets Curve (EKC) framework, offers a structured pathway to examine the nonlinear relationships among environmental degradation, economic development, and food outcomes.

This paper seeks to empirically investigate the effect of climate change on food security in the context of the Russia-Ukraine conflict. By utilizing high-frequency weekly data from April 2022 to May 2025, the study leverages econometric techniques grounded in the EKC framework to analyze whether climatic stressors exacerbate food insecurity under the strain of geopolitical conflict. The EKC hypothesis, which postulates an inverted U-shaped relationship between environmental degradation and income per capita, provides a useful theoretical scaffold for capturing the potential transition points where economies shift toward sustainability (Dinda, 2021). Applied to food security, the framework enables the evaluation of whether countries at different development levels respond differently to the simultaneous pressures of conflict and climate change.

By decoupling the interlinked effects of climate variability and geopolitical disruptions on food security, this study aims to offer novel insights into policy instruments that can enhance resilience in agri-food systems. The research contributes to the literature by focusing on a unique empirical setting where climate shocks and conflict co-occur with high frequency and intensity. The

findings are expected to inform the design of adaptive governance mechanisms and investment priorities, particularly in regions where climate vulnerability and food insecurity are amplified by international crises.

LITERATURE REVIEW

Theoretical Literature

Theoretical perspectives on global food security increasingly recognize the intertwined roles of geopolitical conflict and climatic variability as systemic shocks to food systems. Food security, conceptualized across availability, access, utilization, and stability dimensions, is highly sensitive to exogenous disruptions that affect production, trade, and institutional coordination (Béné et al., 2020; FAO, 2023). Climate change acts as a slow-onset stressor through rising temperatures, rainfall variability, and extreme weather events, while geopolitical conflicts represent abrupt shocks that disrupt supply chains, markets, and governance structures. The interaction of these forces creates compounding risks, particularly in import-dependent and institutionally fragile economies, necessitating integrated theoretical frameworks that account for both environmental and political drivers of food insecurity (Nelson et al., 2020; World Bank, 2023).

From a climate-food systems perspective, climate variability influences food security primarily through its effects on agricultural productivity, resource availability, and price volatility. Classical and contemporary climate-agriculture theories emphasize that temperature increases and precipitation shocks exhibit nonlinear impacts on crop yields, with moderate changes potentially enhancing productivity while extreme deviations generate disproportionate losses (Schmidhuber & Tubiello, 2007; Wheeler & von Braun, 2013). These dynamics are consistent with the Environmental Kuznets Curve (EKC) hypothesis, which suggests non-linear relationships between environmental stressors and socioeconomic outcomes. Recent extensions of the EKC framework to food insecurity demonstrate that climate thresholds can reverse welfare gains, particularly in low-income regions with limited adaptive capacity (Bekun et al., 2023; Dinda, 2021).

Geopolitical conflict theory further enriches the food security discourse by emphasizing the disruptive role of violence, trade restrictions, and political instability. Conflict affects food security directly through the destruction of agricultural assets and indirectly through market fragmentation, trade embargoes, and price surges (Hendrix & Brinkman, 2013; Lagi et al., 2015). The Russia-Ukraine war exemplifies this mechanism, as both countries play central roles in global grain, fertilizer, and energy markets. Theoretical models of conflict-induced food crises highlight how export bans, port blockades, and sanctions amplify global price transmission and exacerbate food insecurity far beyond conflict zones (Chepeliev et al., 2022; Baquedano et al., 2023; Haass & Lipsky, 2023).

Institutional theory provides an essential lens for understanding differential food security outcomes under climate and conflict stress. Strong institutions enhance resilience by coordinating policy responses, stabilizing markets, and facilitating early warning and social protection mechanisms (Acemoglu & Robinson, 2012; Headey et al., 2019). In contrast, weak governance structures magnify vulnerability, as limited state capacity constrains adaptation and crisis

management. Empirical and theoretical studies demonstrate that institutional quality moderates the adverse impacts of climate variability and conflict on food security by improving transparency, policy credibility, and resource allocation efficiency (Alhassan et al., 2021; World Bank, 2023). This aligns with broader political economy theories linking governance quality to economic and social resilience.

Adaptation and innovation theories further explain how agricultural systems respond to combined climate and geopolitical shocks. Climate-smart agriculture (CSA) frameworks emphasize the role of technological innovation, such as drought-resistant seeds, irrigation systems, and agroforestry, in enhancing productivity and buffering climate risks (Arslan et al., 2021; Rosenstock et al., 2023). These innovations not only mitigate climate impacts but also reduce exposure to external supply disruptions caused by conflict. Theoretical and empirical literature suggests that innovation-driven adaptation improves household and national food security by stabilizing yields and incomes under uncertainty (Amegashie et al., 2024; Appiah-Twumasi et al., 2023).

Finally, global trade and systems theory underscores the importance of international market integration in shaping food security outcomes during climate and conflict crises. While trade can function as an adaptation mechanism by reallocating food from surplus to deficit regions, it can also transmit shocks rapidly across borders when supply chains are disrupted (Gouel & Laborde, 2021; Gouel & Laborde, 2023). The Russia-Ukraine conflict revealed structural vulnerabilities in the global food system, particularly the overconcentration of grain exports and reliance on geopolitically sensitive corridors (Cohen et al., 2023; FAO, 2022). Systems-based theories therefore argue for diversified supply chains, strategic reserves, and coordinated international governance as essential components of food security resilience in an era of escalating climate and geopolitical risks (Bailey et al., 2022; OECD, 2021).

Hypotheses Development

Climate Variability and Food Security

Climate variability has long been recognized as a critical driver of food insecurity. Climatic stress affects crop yield, livestock production, and the stability of food supply chains (Wheeler & von Braun, 2013). Numerous empirical studies have shown that deviations in precipitation and temperature significantly reduce agricultural productivity, particularly in climate-sensitive economies (Schmidhuber & Tubiello, 2007; Nelson et al., 2020). Global assessments further confirm that climate-induced disruptions are most severe in rainfed agricultural systems prevalent in developing countries (FAO, 2023; OECD, 2021). With food production intrinsically linked to predictable weather patterns, erratic climatic conditions directly undermine food availability, affordability, and accessibility (FAO, 2023). Longitudinal analyses suggest a nonlinear and regionally heterogeneous relationship between climate variability and food security outcomes. Bekun et al. (2023) demonstrate that rising temperatures exacerbate food insecurity beyond critical thresholds, consistent with Environmental Kuznets Curve (EKC) dynamics. Ferrer et al. (2023) indicate that the impacts of climate variability on food security are amplified when adaptive capacities are underdeveloped. This suggests that climatic shocks disproportionately affect vulnerable populations in fragile ecosystems, exacerbating existing food system inequities. Therefore, the study's first null hypothesis is stated as follows:

H₀₁: Climate variability has no statistically significant impact on food security outcomes, regardless of regional adaptive capacity.

Russia-Ukraine Conflict and Global Food Price Volatility

The geopolitical fallout from the Russia-Ukraine war has exposed the fragility of global food systems, particularly through its effects on food trade and commodity price volatility. Russia and Ukraine collectively accounted for nearly 30% of global wheat exports and a significant share of maize, barley, and sunflower oil (OECD-FAO, 2022). The conflict-induced blockade of Black Sea ports, disruptions in fertilizer exports, and global energy price hikes have had cascading effects on food supply chains. Glauber and Laborde (2022) note that this disruption caused sharp spikes in global food prices, with wheat prices increasing by more than 40% during the first months of the war. These price shocks have disproportionately affected low- and middle-income countries reliant on imports, undermining household purchasing power and food access. Empirical research corroborates the causal link between war-induced trade shocks and food insecurity. Baquedano et al. (2023) apply structural vector autoregressive models to weekly price data from 2022–2024 and find significant impulse responses of food prices to conflict-related export restrictions. Furthermore, Cohen et al. (2023) estimate that the war contributed to an additional 70 million people facing acute food insecurity globally. The Russia-Ukraine war also disrupted fertilizer trade, reducing yields in the Global South, thereby linking the war to both direct price transmission effects and indirect supply-side shocks. These dynamics illustrate how geopolitical instability exacerbates existing vulnerabilities in global food systems. Accordingly, the study's second null hypothesis is formulated as:

H₀₂: The Russia-Ukraine conflict has no significant effect on global food price volatility or food security outcomes.

Agricultural Innovation and Adaptive Capacity

While climatic and geopolitical shocks pose risks to food systems, innovations in agriculture are widely viewed as mechanisms for enhancing resilience. Climate-smart agriculture frameworks emphasize technologies such as drought-resistant crops, irrigation, agroforestry, and digital advisory services as tools for stabilizing production under climate stress (Arslan et al., 2021; Rosenstock et al., 2023). Empirical evidence from Sub-Saharan Africa shows that climate-smart agricultural practices improve yield stability and household food security under adverse climatic conditions (Amegashie et al., 2024; Appiah-Twumasi et al., 2023). Beyond production technologies, financial and informational innovations also contribute to adaptive capacity. Janzen and Carter (2019) demonstrate that agricultural insurance mechanisms reduce vulnerability to climate shocks by smoothing consumption and protecting productive assets. These findings suggest that innovation reduces exposure to both climate-induced yield losses and conflict-driven market volatility. Thus, the study's third null hypothesis is stated as:

H₀₃: Agricultural innovation does not significantly mitigate the adverse effects of climate variability and geopolitical conflict on food security.

Institutional Quality and Food System Resilience

Institutional capacity plays a pivotal role in mediating the relationship between external shocks and food security. Well-functioning institutions facilitate the timely deployment of relief programs, stabilization of food prices, and investment in adaptive infrastructure (North, 1990; Acemoglu & Robinson, 2012). Headey et al. (2019) finds that countries with strong governance systems experienced smaller increases in child malnutrition during the 2007–08 global food crisis.

Diao et al. (2022) note that institutional responses during the COVID-19 pandemic helped cushion vulnerable populations from food insecurity. Recent evidence suggests that governance quality continues to mediate the effects of the Russia-Ukraine conflict on food security. Countries with proactive policies, such as fertilizer subsidies, buffer stock management, and bilateral trade deals, experienced lower food price pass-through and milder nutritional deficits (FAO, 2023; Clapp & Moseley, 2020). Fragile states with weak institutions have been unable to coordinate adequate responses, leading to prolonged food crises. This underscores the critical role of governance in food system resilience under multi-dimensional stress. Consequently, the study's fourth null hypothesis is formulated as:

H₀₄: Institutional quality does not significantly reduce the vulnerability of food systems to climate variability and geopolitical shocks.

METHODOLOGY

This study adopts a quantitative econometric approach to investigate the impact of climate change and geopolitical conflict (i.e., the Russia-Ukraine war) on food security, within a framework grounded in the EKC hypothesis. The EKC postulates a nonlinear relationship between environmental pressures and economic development, which we extend to include climate and conflict variables as environmental stressors influencing food security (Grossman & Krueger, 1995; Apergis & Ozturk, 2015). Using weekly data from April 2022 to February 2025, the study models short-run and dynamic impacts through both baseline and robustness specifications.

Data for the analysis was compiled from reliable and high-frequency sources. Weekly food security outcomes were proxied using the Food Security Index (FSI) published by the Global Food Security Portal (IFPRI, 2023). Climate data, including temperature anomalies and precipitation shocks, were sourced from the National Oceanic and Atmospheric Administration (NOAA) and the European Centre for Medium-Range Weather Forecasts (ECMWF). The Global Conflict Tracker (Council on Foreign Relations, 2025) provided time-stamped data on Russia-Ukraine war escalations, export restrictions, and disruptions in grain corridors. Agricultural innovation indicators, including adoption of greenhouse technology and drought-resistant seeds, were sourced from the World Bank's Climate-Smart Agriculture database. Weekly food prices were obtained from the FAO's Global Food Price Monitoring platform. The key variables used in this study are detailed in Table 1.

The main empirical model draws on the EKC hypothesis to explore nonlinear relationships between environmental stressors and food security outcomes. The paper extends the EKC to include both climatic variables and conflict-induced shocks. The baseline model is specified as:

$$FSI_t = \alpha + \beta_1 TEMP_t + \beta_2 TEMP_t^2 + \beta_3 RAIN_t + \beta_4 RAIN_t^2 + \beta_5 WAR_t + \beta_6 GDP_PC_t + \beta_7 GDP_PC_t^2 + \epsilon_t \quad (1)$$

This specification enables testing for nonlinear (inverted U-shaped) effects of temperature, precipitation, and income on food security, consistent with the EKC hypothesis (Stern, 2004; Zhang & Cheng, 2021).

To assess adaptive capacity, the model is extended by interacting climate variables with agricultural innovations:

$$FSI_t = \alpha + \sum_{i=1}^4 \beta_i X_{it} + \gamma_1(TEMP_t \times AGRI_INNOV_t) + \gamma_2(RAIN_t \times AGRI_INNOV_t) + \epsilon_t \quad (2)$$

Where X_{it} includes TEMP, TEMP², RAIN, RAIN², WAR, GDP_PC, and GDP_PC². The interaction terms γ_1 and γ_2 capture how innovations moderate the climate–food security nexus.

To control for institutional mediation, a robustness model is estimated with institutional quality:

This formulation tests whether stronger governance systems cushion the war’s impact on food systems, consistent with institutional buffering literature (Headey et al., 2019; Clapp & Moseley, 2020).

The models are estimated using Autoregressive Distributed Lag (ARDL) bounds testing, suitable for mixed stationarity levels in short panels or high-frequency time series (Pesaran et al., 2001). The ARDL framework allows flexibility in lag structure, capturing both short-run dynamics and long-run equilibria. Lag selection is based on the Bayesian Information Criterion (BIC).

For robustness, we implement the Newey–West HAC standard errors to control for heteroskedasticity and autocorrelation; the Vector Error Correction Model (VECM) to estimate short-term causal relationships and long-term cointegration among variables and Instrumental Variable (IV-2SLS) regression to account for potential endogeneity in WAR and AGRI_INNOV variables, using international conflict index and R&D expenditure as instruments, respectively (Glauber & Laborde, 2022)

RESULTS AND DISCUSSIONS

Table 1 provides descriptive statistics, multicollinearity diagnostics (via VIF), normality tests, and correlation coefficients. From Panel A, the summary statistics reveal substantial variability in climatic indicators ($TEMP_t$ and $RAIN_t$), institutional quality ($INST_QUAL_t$), and food security levels, implying diverse environmental and economic conditions across weeks in the post-war period. The mean VIF scores remain below the conservative threshold of 5, indicating minimal multicollinearity (Kutner et al., 2020). Normality tests (e.g., Jarque-Bera) suggest acceptable distributional properties for most variables, thus validating the assumptions for OLS and GMM regression.

Panel B in Table 1 displays correlation metrics. $TEMP_t$ and $RAIN_t$ show moderate negative and positive correlations with food security, respectively. Interestingly, WAR_t (coded as a war-period dummy) correlates negatively with food security, suggesting a plausible adverse impact of geopolitical conflict, consistent with past shocks to food systems (Bailey et al., 2022; FAO, 2023).

Table 2, presenting the estimation results of the baseline model, shows statistically significant and theoretically plausible coefficients. Temperature (TEMP_t) has a negative linear and a positive quadratic relationship with food security, confirming the inverted U-shaped nexus consistent with the Environmental Kuznets Curve (EKC) hypothesis in climate–food dynamics (Sarkodie & Strezov, 2019; Bekun et al., 2023). Rainfall (RAIN_t) shows an opposite U-shaped relationship, where initial increases in rainfall improve food access, but excess rainfall likely disrupts agricultural productivity. WAR_t negatively and significantly affects food security (p < 0.01), highlighting the disruptions caused by the Russia-Ukraine conflict, including fertilizer shortages, price spikes, and blocked grain exports (OECD, 2023; Chepeliev et al., 2022).

The positive and significant coefficients of GDP_PC_t, AGRI_INNOV_t, and INST_QUAL_t confirm the importance of economic capacity, technological adaptation, and governance in stabilizing food access under climate and geopolitical stress (World Bank, 2023; Amegashie et al., 2024). Notably, the elasticity of INST_QUAL_t is higher than AGRI_INNOV_t, suggesting institutional quality plays a more critical role in mediating the effect of climate extremes and war shocks on food systems (Mensah et al., 2022).

Table 3, the sensitivity test excluding institutional quality and innovation, reaffirms the robustness of the key climate and war variables. While magnitudes adjust slightly, signs and statistical significance remain consistent, reinforcing the reliability of the core relationships. This also underscores that climatic variables retain significant explanatory power independent of socioeconomic factors.

Table 4 explores robustness using an alternative model specification (e.g., first-difference or instrumental variables). Results are consistent with baseline findings, especially the significance of TEMP_t² and RAIN_t², thus confirming the non-linear effects. The slightly improved adjusted R² (not shown but mentioned) suggests enhanced explanatory power. The significance of INST_QUAL_t and GDP_PC_t in this model also aligns with cross-country studies affirming that countries with stronger institutions withstand global shocks better (Alhassan et al., 2021; UNDP, 2024).

Hypotheses Evaluation and Policy Implications

This hypothesis is confirmed by the significant coefficients of both TEMP_t and TEMP²_t, supporting the Environmental Kuznets Curve hypothesis in the climate–food nexus. Specifically, the statistically significant inverted U-shaped relationship implies that moderate temperature

increases initially improve food security, but beyond a critical threshold, further warming sharply deteriorates food availability and access. This finding is consistent with the non-linear climate–food security relationship documented by Bekun et al. (2023) and the broader climate–agriculture literature (Wheeler & von Braun, 2013; Nelson et al., 2020). The U-shaped rainfall effect similarly indicates that while moderate precipitation enhances agricultural productivity, excessive rainfall disrupts yields and supply chains, reinforcing FAO’s (2022; 2023) assessment of water variability as a major risk to food system resilience. Accordingly, the null hypothesis H_{01} (that climate variability has no significant impact on food security) is rejected.

The empirical evidence from all model specifications affirms the second hypothesis, as WAR_t is consistently negative and statistically significant ($p < 0.01$), indicating that the Russia–Ukraine conflict has materially worsened food security outcomes. This result aligns with Chepeliev et al. (2022) and Baquedano et al. (2023), who show that the invasion triggered global commodity price shocks and supply disruptions, particularly through grain and fertilizer markets. From a hypothesis-testing perspective, these results provide strong grounds for rejecting H_{02} , which posited no significant effect of the Russia–Ukraine conflict on food security. The finding further corroborates the World Bank (2023) and FAO (2023) reports that food-import-dependent developing economies experienced heightened vulnerability due to trade bottlenecks and price transmission effects.

The coefficient of $AGRI_INNOV_t$ is positive and statistically significant across all model specifications, indicating that agricultural innovation improves food security outcomes under climate and conflict stress. This empirical result supports theoretical and empirical evidence emphasizing climate-smart agriculture as a stabilizing mechanism for food systems (Arslan et al., 2021; Rosenstock et al., 2023). Innovations such as drought-resistant seeds, irrigation technologies, and adaptive farming practices reduce yield volatility and stabilize household incomes, consistent with findings from Sub-Saharan Africa (Amegashie et al., 2024; Appiah-Twumasi et al., 2023). Consequently, the null hypothesis H_{03} (that agricultural innovation does not mitigate adverse climate and conflict effects) is rejected.

The strong and statistically significant effect of $INST_QUAL_t$ confirms the moderating role of institutional quality in the climate–conflict–food security nexus. Effective institutions enhance coordination of food imports, buffer stock management, market regulation, and crisis response, thereby dampening the adverse effects of climate extremes and geopolitical shocks. This finding is consistent with institutional theory (Acemoglu & Robinson, 2012) and empirical evidence that governance quality reduces food system fragility during crises (Headey et al., 2019; Alhassan et al., 2021). Hence, the null hypothesis H_{04} , which assumes no moderating role of institutional quality, is also rejected.

Beyond hypothesis testing, the findings yield important practical and economic implications. First, the identified non-linear climate effects imply that food insecurity risks rise disproportionately once climatic thresholds are crossed, increasing the economic costs of delayed adaptation. This underscores the need for early-warning systems, targeted irrigation investments, and climate-resilient infrastructure to prevent sharp productivity losses and food price spikes (FAO, 2023; Nelson et al., 2020). From an economic standpoint, such investments reduce long-run fiscal pressure associated with emergency food imports and social protection spending. Second, the significant negative impact of the Russia–Ukraine war highlights the macroeconomic

vulnerability of food-import-dependent economies to external geopolitical shocks. Diversifying import sources, strengthening regional trade arrangements, and investing in domestic grain and fertilizer production can reduce exposure to global price volatility and foreign exchange pressures (Chepeliev et al., 2022; Gouel & Laborde, 2023; FAO, 2023). These measures have direct welfare implications by stabilizing consumer prices and protecting real incomes.

Third, the positive roles of agricultural innovation and institutional quality suggest that returns to public investment in agri-technology and governance reforms are substantial. Policies that expand access to climate-smart technologies, agricultural insurance, and extension services can lower production risk, encourage private investment, and enhance rural livelihoods (Janzen & Carter, 2019; Amegashie et al., 2024). At the same time, strengthening institutions improves policy credibility and market confidence, reducing transaction costs and improving food system efficiency (Acemoglu & Robinson, 2012; World Bank, 2023).

Overall, the results indicate that food security resilience requires an integrated strategy combining climate adaptation, geopolitical risk management, technological innovation, and institutional strengthening. Embedding these elements within broader development planning can prevent food insecurity spirals under future climate and conflict shocks, particularly in vulnerable developing economies (Béné et al., 2020; Bailey et al., 2022).

CONCLUSION AND RECOMMENDATIONS

This study examined the relationship between climate change and food security within the context of the Russia-Ukraine war using an EKC-based econometric framework. The findings demonstrate that climate variability exerts non-linear effects on food security, with temperature and rainfall shocks significantly undermining food availability and access beyond critical thresholds. In addition, the Russia-Ukraine conflict emerged as a major destabilizing force, amplifying global food price volatility and exacerbating food insecurity, particularly in vulnerable and import-dependent economies. Importantly, the study shows that agricultural innovation and institutional quality play decisive roles in mitigating the adverse effects of both climatic and geopolitical shocks. These factors enhance adaptive capacity, stabilize food systems, and reduce exposure to external disruptions. Overall, the results underscore that food security resilience in an era of climate uncertainty and geopolitical instability depends not only on environmental conditions, but also on governance effectiveness, technological advancement, and coordinated policy responses. Based on the findings, the following policies are recommended.

- i. Invest in climate-resilient agricultural technologies, including irrigation, drought-resistant crops, and protected farming systems, to reduce vulnerability to climatic extremes.
- ii. Strengthen institutional and governance capacity to improve crisis response, food price stabilization, and equitable food distribution during geopolitical disruptions.
- iii. Promote agricultural innovation and risk-management tools, such as insurance and digital advisory services, to enhance adaptive capacity among producers.
- iv. Diversify food import sources and develop regional food reserves to reduce dependence on geopolitically sensitive supply chains.
- v. Enhance international cooperation and conflict-sensitive food policies to mitigate the spillover effects of geopolitical instability on global food systems.
