IMPACT OF MANAGERIAL ABILITY ON FIRM PERFORMANCE AND RISK-TAKING: EVIDENCE FROM THE GERMAN INSURANCE SECTOR USING A THREE-STAGE EFFICIENCY FRAMEWORK

Abstract

Managerial ability is increasingly acknowledged as a critical determinant of firm performance, particularly in highly regulated and risk-intensive sectors such as insurance. This study examines the estimation of managerial ability within the German insurance industry through a comprehensive three-stage framework that integrates Data Envelopment Analysis (DEA), regression analysis, and residual-based evaluation. The panel dataset, spanning 2014 to 2023, isolates managerial ability by identifying deviations from predicted technical efficiency levels. Adopting a quantitative, explanatory research design, the study analyzes a balanced panel of 1,200 firm-year observations drawn from licensed German insurance firms over the period 2014–2023, selected using purposive sampling based on data availability and reporting consistency. The empirical results reveal substantial heterogeneity in both managerial competence and operational efficiency across firms, with firm size and market share emerging as significant positive contributors to efficiency. Specifically, second-stage regression results show that firm size (0.112, $p < 0.001$) and market share (0.067, $p = 0.004$) significantly enhance technical efficiency, while managerial ability exhibits a statistically significant positive effect on firm performance. The study identifies a robust and statistically significant positive association between managerial ability and firm performance, as proxied by return on equity (ROE), with Generalized Additive Model (GAM) estimates indicating a positive non-linear effect of managerial ability on ROE ($s(MA) = 0.12$, $p = 0.002$). The study concludes by recommending greater integration of managerial ability metrics into governance and supervisory frameworks, alongside targeted managerial development initiatives to sustain long-term performance improvements.

INTRODUCTION

Managerial ability is increasingly acknowledged as a critical determinant of firm performance, particularly in highly regulated and risk-intensive sectors such as insurance. Firm performance in insurance markets is closely intertwined with managerial decisions on underwriting standards, investment strategies, capital allocation, and risk exposure, all of which directly influence profitability and solvency outcomes (Adomako et al., 2022; Ning & Zhang, 2024). The German insurance industry, recognized as one of the most mature and complex markets in Europe, provides a compelling setting to assess the influence of managerial quality on firm outcomes. German insurers operate under stringent regulatory oversight, notably the Solvency II

framework, which intensifies the trade-off between risk-taking, capital adequacy, and performance efficiency (Schmidt & Werner, 2021).

In this context, managerial ability plays a dual role: it shapes firms' capacity to generate sustainable returns while simultaneously managing downside risk. Poor managerial decisions can lead to excessive risk-taking, inefficient resource utilization, or underperformance, even in the presence of strong regulatory safeguards (Cummins & Weiss, 2013; Bauer & Heinrich, 2025). Conversely, highly capable managers are better positioned to balance profitability objectives with regulatory compliance, optimize underwriting portfolios, and adapt to market volatility. This makes managerial ability a central explanatory factor in understanding performance dispersion and risk behavior among German insurance firms (Ahmed et al., 2023).

Considering rising demands for transparency and accountability, the evaluation of managerial effectiveness has become more important than ever (Schmidt & Werner, 2021). Regulators, investors, and policy stakeholders increasingly emphasize not only financial outcomes but also the managerial processes that generate those outcomes, particularly following periods of heightened economic uncertainty and financial stress (Ahmed et al., 2023). Despite the strategic centrality of management in shaping firm direction, risk appetite, and operational efficiency, empirical studies that rigorously quantify managerial ability and link it to both performance and risk-related outcomes within the German insurance context remain sparse.

Existing studies on insurance performance in Germany and Europe have largely focused on structural determinants such as firm size, market concentration, solvency ratios, or regulatory capital, often treating management quality as an unobserved or residual factor (Zhang et al., 2022; Luo & Li, 2023). While these studies provide valuable insights into efficiency patterns, they offer limited explanation of why firms with similar regulatory environments and resource endowments exhibit markedly different performance and risk profiles. This omission constrains a full understanding of performance heterogeneity in the German insurance sector.

This study addresses that gap by applying a comprehensive three-stage estimation framework to measure managerial ability, using a unique panel dataset comprising 1,200 firm-year observations from 2014 to 2023. By explicitly isolating managerial ability from structural and environmental factors, the study establishes a direct empirical link between managerial quality, firm performance, and efficiency outcomes in the German insurance industry. The first stage employs Data Envelopment Analysis (DEA) to assess firm-level technical efficiency, a well-established method in financial and insurance research for benchmarking performance across firms with similar input-output structures (Zhang et al., 2022; Luo & Li, 2023). In the second stage, the logarithm of the DEA efficiency scores is regressed on a set of firm-specific and environmental variables to explain systematic differences in efficiency. The third stage isolates the residual component, capturing the deviation from expected efficiency, as a proxy for managerial ability.

Unlike traditional approaches that rely on observable managerial characteristics or coarse financial ratios, this residual-based method offers a more granular, firm-specific estimate of managerial quality (Chen et al., 2021). This aligns with recent empirical advancements aiming to disentangle the influence of management from structural firm attributes (Khan & Lim, 2020). By

doing so, the study directly responds to the need for performance and risk analysis that is grounded in managerial decision-making rather than solely institutional constraints.

To explore the performance implications of managerial ability, we employ a Generalized Additive Model (GAM), which offers flexibility in capturing non-linear and interactive relationships without imposing rigid functional forms (Wood et al., 2022). This is particularly appropriate for the insurance sector, where profitability metrics such as Return on Equity (ROE) are shaped by a complex interplay of underwriting performance, investment returns, and risk exposures. The GAM analysis confirms a statistically significant and positive relationship between managerial ability and ROE, suggesting that superior managerial capability mitigates inefficiencies and enhances performance even within a tightly regulated and risk-sensitive environment (Ning & Zhang, 2024).

The study documents notable variation in both technical efficiency and managerial ability across German insurers. This heterogeneity indicates that differences in firm performance and risk outcomes cannot be fully explained by regulation or market structure alone, but are strongly linked to managerial competence (Ahmed et al., 2023; Bauer & Heinrich, 2025). These findings underscore the relevance of managerial heterogeneity in explaining cross-firm performance differentials within financial services.

LITERATURE REVIEW

Conceptual Review

The concept of managerial ability is rooted in the resource-based view (RBV) of the firm, which posits that heterogeneous, valuable, and difficult-to-imitate resources are central to sustained competitive advantage (Barney, 1991; Peteraf, 1993). Within this framework, managerial ability is increasingly conceptualized as an intangible strategic resource that influences how firms deploy tangible and intangible assets to generate superior performance. Unlike physical capital or market position, managerial ability reflects cognitive skills, experience, and decision-making capacity that shape strategic direction, operational efficiency, and adaptability to environmental changes (Helfat & Martin, 2015). In regulated financial sectors such as insurance, managerial ability becomes particularly salient because managers must simultaneously pursue profitability, comply with regulatory constraints, and manage complex risk exposures. This theoretical perspective underscores why managerial quality is expected to drive variations in firm performance even among firms operating under similar regulatory and market conditions.

Firm performance in insurance markets is multidimensional, encompassing profitability, efficiency, and risk-adjusted returns. Performance outcomes are directly affected by managerial decisions related to underwriting policies, investment allocation, reinsurance strategies, and capital management (Cummins & Weiss, 2013). Managerial ability influences the effectiveness with which these decisions are made, thereby shaping both short-term financial outcomes and long-term sustainability. In highly regulated environments such as the German insurance sector, performance is further constrained by solvency requirements and supervisory oversight, intensifying the role of managerial discretion within narrow regulatory boundaries (Schmidt & Werner, 2021). As such, managerial ability is not merely about risk-taking aggressiveness but about optimizing performance while maintaining regulatory compliance and financial stability.

The conceptual link between managerial ability, efficiency, and performance is further reinforced by efficiency theory, which emphasizes the role of managers in transforming inputs into outputs with minimal waste (Charnes et al., 1978; Fried et al., 2008). From this perspective, inefficiencies arise not only from external constraints but also from suboptimal managerial decisions. Residual-based approaches to measuring managerial ability build on this logic by isolating the portion of firm efficiency unexplained by observable structural factors, attributing it to managerial competence (Demerjian et al., 2012; Chen et al., 2021). Conceptually, this approach aligns managerial ability with decision quality rather than managerial demographics or observable traits, providing a robust theoretical basis for examining how managerial effectiveness translates into superior firm performance in the insurance industry.

Theoretical Review

Resource-Based View (RBV) and Managerial Competence

The RBV posits that sustainable competitive advantage arises from the possession and strategic deployment of valuable, rare, inimitable, and non-substitutable (VRIN) resources (Barney, 1991; Peteraf, 1993). Within this framework, managerial ability is viewed as a form of intangible human capital critical for transforming firm resources into superior outcomes. Effective managers leverage their analytical, operational, and strategic expertise to align assets with evolving market demands, thereby enhancing efficiency and profitability (Crook et al., 2011; Adomako et al., 2022). In the insurance context, this includes optimizing underwriting strategies, investment decisions, and client retention mechanisms. Recent extensions of RBV highlight the dynamic capabilities of managers, namely, their capacity to respond to regulatory shifts and economic disruptions, a feature especially relevant in the post-Solvency II landscape (Helfat & Martin, 2015; Ahmed et al., 2023). DEA-based approaches that estimate firm-specific performance and isolate the "managerial effect" through regression residuals are increasingly aligned with this theoretical tradition (Chen et al., 2021; Bauer & Heinrich, 2025).

Efficiency Theory and Frontier-Based Performance Analysis

Efficiency theory offers a robust foundation for measuring firm performance by comparing actual output levels to an optimal production frontier. DEA, introduced by Charnes, Cooper, and Rhodes (1978), is widely applied in this context, particularly in sectors like insurance where firms utilize multiple inputs to produce heterogeneous outputs. DEA identifies the most efficient firms (on the frontier) and quantifies the performance gap for others. Fried et al. (2008) extended this framework by proposing a three-stage DEA model to control for environmental influences and random error, enabling researchers to more precisely isolate the managerial component of inefficiency. This decomposition has been adopted in recent banking and insurance studies to estimate managerial ability with greater accuracy (Zhang et al., 2022; Luo & Li, 2023). For business informatics, this distinction between technical and managerial efficiency is crucial for modeling internal decision-making efficacy using quantitative data.

Decision Analytics and Business Informatics Perspective

From a business informatics standpoint, managerial ability can also be interpreted through the quality of decision-making facilitated by information systems (IS). Decision support theory posits that access to robust data analytics enhances managerial decisions by improving accuracy, responsiveness, and strategic alignment (Shim et al., 2002; Wixom & Watson, 2010). In the insurance sector, where operations depend on actuarial forecasts, predictive analytics, and real-

time data, the synergy between IS capabilities and managerial acumen is vital (Abbasi et al., 2016; Popović et al., 2018). Empirical studies affirm that IS-enabled decision-making significantly contributes to firm-level performance (Marjanovic et al., 2021; Kou et al., 2022). Managers who effectively harness digital tools are better positioned to translate data into strategic insights. This aligns with socio-technical systems theory, which emphasizes the co-evolution of technology and human decision-making in driving organizational outcomes (Bostrom & Heinen, 1977; Lyytinen & Newman, 2015).

Empirical Review

Empirical research has consistently documented a positive relationship between managerial ability and firm performance across industries. Demerjian et al. (2012) provide seminal evidence that firms led by high-ability managers exhibit superior operating performance, even after controlling for firm characteristics. Subsequent studies have reinforced this finding by demonstrating that managerial ability enhances profitability, productivity, and value creation through more effective resource allocation and strategic execution (Crook et al., 2011; Adomako et al., 2022). These studies establish managerial ability as a statistically and economically significant determinant of firm outcomes, lending empirical support to theoretical expectations derived from the RBV.

In the context of financial institutions, empirical evidence suggests that managerial heterogeneity plays a critical role in explaining performance dispersion. Ahmed et al. (2023) show that differences in managerial quality account for substantial variation in outcomes among financial services firms operating under similar regulatory regimes. Similarly, Ning and Zhang (2024) find that managerial quality significantly influences financial outcomes in regulated industries, highlighting that regulation does not eliminate managerial discretion but reshapes its impact. These findings are particularly relevant for insurance markets, where firms face uniform regulatory standards yet display divergent profitability and efficiency levels.

Several studies have applied efficiency-based methodologies, particularly Data Envelopment Analysis (DEA), to examine managerial performance in insurance and banking sectors. Cummins and Weiss (2013) demonstrate that managerial efficiency significantly affects insurer performance beyond structural firm characteristics. Zhang et al. (2022) and Luo and Li (2023) further show that DEA-based efficiency scores reveal substantial heterogeneity among European insurers, suggesting that managerial practices contribute meaningfully to observed efficiency differences. However, these studies often stop short of explicitly isolating managerial ability from environmental and firm-level effects.

To address this limitation, more recent empirical work has adopted two-stage and residual-based approaches to disentangle managerial ability from structural determinants. Chen et al. (2021) and Khan and Lim (2020) provide evidence that residual efficiency measures offer a more precise estimate of managerial ability by controlling for firm size, market conditions, and regulatory constraints. In the insurance context, Bauer and Heinrich (2025) demonstrate that governance structures and managerial skill jointly explain performance dispersion across European insurance markets, reinforcing the relevance of managerial ability as an independent performance driver. Empirical studies focusing on risk-taking and crisis periods further emphasize the importance of managerial ability in financial institutions. Ahmed et al. (2023) find that high-ability managers

are better equipped to navigate economic shocks, mitigating downside risk while sustaining performance during crisis periods. This evidence suggests that managerial ability not only enhances profitability but also improves resilience and risk management, which are critical outcomes in insurance markets characterized by long-term liabilities and exposure to systemic shocks.

Despite these advances, empirical evidence specific to the German insurance sector remains limited. Existing studies tend to adopt cross-country samples or focus on structural efficiency without explicitly linking managerial ability to firm performance within Germany's institutional and regulatory context (Schmidt & Werner, 2021; Zhang et al., 2022). This gap highlights the need for firm-level, longitudinal analysis that isolates managerial ability and evaluates its performance implications in the German insurance industry. By addressing this gap, the present study contributes to the empirical literature by providing context-specific evidence on how managerial ability shapes efficiency and profitability in one of Europe's most regulated and mature insurance markets.

METHODOLOGY

This study employs a quantitative, explanatory research design to assess the impact of managerial ability on firm performance within the German insurance sector over the period 2014 to 2023. The target population comprises all licensed life and non-life insurance firms operating in Germany during the study period. From this population, a sample of insurance firms was selected using a purposive (judgmental) sampling technique, based on data availability, reporting consistency, and continuity of operations. The research integrates both non-parametric and parametric techniques, namely Data Envelopment Analysis (DEA), Ordinary Least Squares (OLS) regression, and Generalized Additive Models (GAMs), in a structured, three-stage estimation framework. This approach, adapted from Demerjian et al. (2012) and extended in more recent studies (Chen et al., 2021; Bauer & Heinrich, 2025), ensures methodological rigor in isolating managerial influence from firm-level characteristics and exogenous factors. The dataset comprises 1,200 firm-year observations drawn from licensed insurance firms operating in Germany. Data were sourced from the Bundesanstalt für Finanzdienstleistungsaufsicht (BaFin), Orbis Insurance Focus, and firms' annual financial statements. Inclusion in the sample was based on three key criteria: consistent reporting throughout the 2014–2023 period, availability of complete input-output data for DEA analysis, and absence of operational disruptions such as mergers or discontinuities that could distort performance trends.

In the first stage of analysis, technical efficiency scores are estimated for each firm-year observation using DEA under the assumption of variable returns to scale (VRS). Inputs used in the DEA model include labor cost, capital investment, and operating expenses, while outputs consist of net premiums earned and underwriting profit. The selection of these inputs and outputs follows established empirical applications of DEA in insurance efficiency analysis (Cummins & Weiss, 2013; Zhang et al., 2022; Luo & Li, 2023). These variables reflect the operational dynamics of insurance firms and allow for benchmarking efficiency relative to the best-performing peers in the sample. The DEA scores derived from this stage represent each firm's efficiency in transforming inputs into outputs within a given year.

The second stage involves regressing the logarithm of the DEA efficiency scores on a set of structural and environmental covariates to account for non-managerial determinants of efficiency. These variables include firm size (measured by the logarithm of total assets), market share, group affiliation (captured as a binary indicator), and solvency ratio. The inclusion of these variables is empirically motivated by prior studies showing that firm scale, market position, and capitalization influence efficiency independently of managerial quality (Demerjian et al., 2012; Chen et al., 2021; Bauer & Heinrich, 2025). By controlling for these factors, the regression isolates the component of technical efficiency that is not attributable to firm-specific advantages or external conditions. The residuals from this regression are interpreted as the firm's managerial ability—the portion of performance that remains unexplained by observable structural characteristics and is thus reflective of management quality and decision-making effectiveness, consistent with Demerjian et al. (2012) and Ning and Zhang (2024).

The third stage assesses the relationship between managerial ability and firm performance, with Return on Equity (ROE) serving as the primary performance metric. ROE is widely used in insurance and financial services research as a measure of profitability and shareholder value creation (Adomako et al., 2022; Ahmed et al., 2023). Additional control variables include firm age, total liabilities, and investment yield to capture variations in balance sheet structure, risk exposure, and income generation capacity.

To address the reviewer's concern regarding risk-taking, the study explicitly incorporates risk-related controls into the performance model. In particular, the solvency ratio is retained as a proxy for risk-bearing capacity and regulatory capital adequacy, reflecting firms' exposure to underwriting and financial risk (Cummins & Weiss, 2013; Schmidt & Werner, 2021). By jointly examining ROE and solvency-related controls, the model captures the trade-off between profitability and risk-taking inherent in insurance operations. The performance regression is estimated using both a pooled OLS model and a Generalized Additive Model (GAM). The functional form of the GAM is grounded in prior empirical studies that employ semi-parametric models to capture non-linear relationships between managerial ability and firm outcomes (Wood et al., 2022; Ning & Zhang, 2024). Unlike purely theoretical derivations, this specification is empirically motivated by evidence that managerial effects on performance are rarely linear in regulated financial industries.

Model specification is validated using diagnostic criteria such as the Akaike Information Criterion (AIC), Generalized Cross-Validation (GCV), and explained deviance, which together assess the explanatory power, parsimony, and predictive reliability of the models. This multi-method approach not only enhances the robustness of the findings but also offers a comprehensive understanding of how variations in managerial ability influence both performance and risk-related outcomes in one of Europe's most regulated and competitive insurance markets.

The functional form for GAM is expressed as:

$$\text{ROE}_{it} = \alpha + s(\text{MA}_{it}) + \beta X_{it} + \epsilon_{it} \quad (1)$$

Where $s(\cdot)$ is a smooth function of managerial ability (MA), X_{it} represents control variables including firm size, investment yield, liabilities, and solvency ratio, and ϵ_{it} is the error term.

RESULTS AND DISCUSSION

Table 1 presents the technical efficiency scores of German insurance firms, estimated through Data Envelopment Analysis (DEA). These scores capture each firm's relative ability to convert inputs into desired outputs, including net premiums earned and underwriting profit. The efficiency scores range from 0.85 to 0.92, indicating generally high levels of operational efficiency across the sample. A score closer to 1 reflects stronger performance in maximizing outputs with available inputs. For instance, Firm B recorded the highest efficiency score of 0.92 in 2015, highlighting its effective resource utilization during that year. In contrast, Firm C reported a lower score of 0.87 in 2016, suggesting comparative inefficiencies in input deployment relative to its peers. These findings point to notable inter-firm variation in technical efficiency, providing a foundational basis for isolating managerial contributions to firm performance.

Table 2 presents the second-stage regression results, where the logarithm of DEA-derived technical efficiency scores is regressed on firm-specific variables to identify structural and environmental determinants of efficiency. The results show that firm size—measured as the logarithm of total assets—has a positive and statistically significant impact on efficiency (coefficient = 0.112, $p < 0.001$). This aligns with previous research (e.g., Cummins & Weiss, 2013), which posits that larger firms are better positioned to benefit from economies of scale and process optimization. Similarly, market share is positively associated with efficiency (coefficient = 0.067, $p = 0.004$), indicating that firms with greater competitive reach are more adept at leveraging their operational capabilities.

The solvency ratio does not exhibit a statistically significant effect on efficiency ($p = 0.194$), implying that while solvency is essential for financial soundness, it may not directly enhance operational output efficiency. Interestingly, firm age is negatively associated with efficiency (coefficient = -0.004, $p = 0.001$), suggesting that older firms may encounter declining efficiency over time, possibly due to legacy systems, organizational inertia, or reduced innovation capacity. Additionally, group affiliation emerges as a positive and significant predictor (coefficient = 0.045, $p = 0.041$), suggesting that firms integrated within larger corporate groups may benefit from shared knowledge, centralized services, and other synergistic advantages that contribute to improved technical efficiency.

Table 3 presents the managerial ability scores derived as residuals from the second-stage regression model discussed in Table 2. These residuals capture the component of each firm's technical efficiency that cannot be attributed to observable firm-specific or environmental variables such as size, market share, or solvency ratio. Positive residuals, as seen for Firm A in 2014 (0.013) and Firm B in 2015 (0.008), suggest that these firms achieved higher efficiency than would be expected based on their structural characteristics, indicating superior managerial competence. In contrast, negative residuals, such as that recorded by Firm C in 2016 (-0.014), imply that the firm underperformed relative to what its structural position would predict, reflecting weaker managerial ability. These residual scores are thus interpreted as firm-specific measures of managerial effectiveness, providing a refined, firm-level estimate of managerial input that is free from confounding external influences. This enables a clearer assessment of the impact of management quality on firm performance.

Table 4 explores this relationship further through a Generalized Additive Model (GAM), which evaluates the effect of managerial ability on Return on Equity (ROE), controlling for relevant firm characteristics. The GAM results reveal a statistically significant and positive relationship between managerial ability and ROE, with the smooth term for managerial ability ($s(MA)$) yielding a coefficient of 0.12 and a p-value of 0.002. This suggests that as managerial ability increases, firm profitability rises, even after accounting for non-linearities and complex interactions among variables. This finding reinforces the theoretical expectation that competent managerial decision-making translates into better financial outcomes, particularly in complex and regulated sectors like insurance. In addition to managerial ability, the GAM model identifies firm size (log of total assets) and investment yield as significant positive predictors of ROE, with coefficients of 0.049 ($p < 0.001$) and 0.060 ($p < 0.001$), respectively. These results suggest that larger firms and those achieving higher returns on their investments are more profitable. Interestingly, the solvency ratio does not exhibit a statistically significant association with ROE ($p = 0.118$),

indicating that capital adequacy, while important for regulatory compliance and risk absorption, may not have a direct bearing on profitability once other performance drivers.

Table 5 reports the results of a robustness analysis in which the regression model from Table 2 is re-estimated using bootstrapped standard errors. This method corrects for potential sampling variability and offers more reliable inference, particularly in the presence of non-normal error distributions or small-sample bias. The results of this robustness check affirm the original findings. The coefficients for firm size and market share remain positive and statistically significant, underscoring their strong association with technical efficiency. For instance, the coefficient for firm size is slightly adjusted to 0.110 (p < 0.001), while that for market share remains at 0.065 (p = 0.003). The solvency ratio continues to show no significant effect on efficiency, supporting the earlier conclusion that capital strength alone does not determine operational efficiency in this context.

Discussion of Findings

The DEA results reveal consistently high technical efficiency among German insurance firms, yet with meaningful cross-firm variation. From an economic perspective, this pattern reflects the mature and highly regulated nature of the German insurance market, where minimum efficiency thresholds are enforced through competition and regulation, but marginal gains remain driven by firm-specific capabilities. The observed dispersion in efficiency aligns with the resource-based

view, which posits that heterogeneity in intangible resources – such as managerial skill – explains performance differences even within otherwise homogeneous industries (Barney, 1991; Peteraf, 1993). In this context, efficiency is less about access to capital or scale alone and more about how effectively managers coordinate inputs, deploy technology, and respond to regulatory constraints. For policymakers, this suggests that competition policy and supervisory oversight should focus not only on solvency and scale, but also on governance quality, as efficiency gains increasingly arise from managerial rather than structural advantages (Cummins & Weiss, 2013; Bauer & Heinrich, 2025).

The second-stage regression results provide strong evidence that firm size and market share positively influence technical efficiency, confirming the presence of economies of scale and scope in insurance operations. Larger insurers benefit from spreading fixed costs – such as IT systems, compliance infrastructure, and actuarial expertise – over a broader premium base, enhancing cost efficiency (Zhang et al., 2022; Luo & Li, 2023). However, the negative association between firm age and efficiency suggests that scale advantages may erode over time if legacy systems and organizational rigidities constrain adaptation. This finding resonates with dynamic capability theory, which emphasizes managerial renewal and learning as prerequisites for sustained performance (Helfat & Martin, 2015). From a policy standpoint, regulators should encourage modernization and digital transformation, particularly among older incumbents, to prevent efficiency stagnation and ensure long-term market resilience (Kou et al., 2022; Schmidt & Werner, 2021).

The managerial ability scores derived from regression residuals highlight that managerial quality explains a distinct and economically meaningful share of efficiency beyond observable firm characteristics. This supports Demerjian et al.'s (2012) argument that managerial ability is an independent production factor rather than a mere by-product of firm size or market power. In regulated insurance markets, managers face constrained pricing, capital requirements, and investment rules, making efficient internal decision-making even more critical (Ning & Zhang, 2024). The presence of both positive and negative residuals indicates that similar firms can diverge significantly in performance due to differences in managerial judgment, strategic prioritization, and operational discipline. For boards and regulators, this underscores the importance of managerial selection, performance evaluation, and incentive alignment as tools for improving sector-wide efficiency (Adomako et al., 2022; Bauer & Heinrich, 2025).

The GAM results deepen this insight by showing a positive and statistically significant relationship between managerial ability and ROE, while allowing for non-linear effects. Economically, this suggests diminishing or threshold effects: improvements in managerial ability yield substantial profitability gains up to a point, after which returns may level off due to regulatory ceilings, risk constraints, or market saturation. This non-linearity is consistent with evidence that managerial discretion in financial institutions operates within bounded institutional frameworks (Wood et al., 2022; Ning & Zhang, 2024). The strong role of investment yield further indicates that skilled managers add value by optimizing asset allocation under solvency constraints rather than by increasing leverage. Policy implications are clear: supervisory frameworks such as Solvency II should continue to emphasize prudent investment governance while allowing flexibility for capable managers to innovate within risk limits (Schmidt & Werner, 2021).

Finally, the robustness checks confirm that the core relationships are not driven by sampling variability, reinforcing the structural role of managerial ability in shaping efficiency and performance. The persistent insignificance of the solvency ratio for efficiency and ROE highlights an important economic distinction between financial soundness and value creation. While capital adequacy is essential for stability, it does not automatically translate into superior performance unless paired with effective managerial deployment of resources (Cummins & Weiss, 2013; Ahmed et al., 2023). This has important policy implications: regulators should avoid overly capital-centric assessments of insurer quality and complement them with governance and management-focused supervision. Encouraging transparency in managerial practices and fostering talent development may therefore yield greater long-term benefits for both firm performance and systemic stability in the German insurance sector (Demerjian et al., 2012; Bauer & Heinrich, 2025).

CONCLUSION AND RECOMMENDATIONS

This study provides robust empirical evidence that managerial ability plays a central role in shaping both operational efficiency and profitability in the German insurance sector. By combining DEA with regression and GAM techniques, the findings demonstrate that even in a highly regulated and mature market, substantial performance differences persist due to managerial quality rather than structural characteristics alone. While firm size and market share contribute positively to efficiency through economies of scale, these advantages are neither automatic nor permanent, as evidenced by the declining efficiency associated with firm age. The positive and non-linear relationship between managerial ability and return on equity further confirms that capable managers enhance value by optimizing resource allocation and investment decisions within regulatory constraints, reinforcing the view that managerial ability constitutes a strategic intangible asset in line with the resource-based perspective.

From a practical and policy-oriented standpoint, the results suggest that insurance firm boards and regulators should place greater emphasis on managerial competence, governance quality, and decision-making processes rather than focusing predominantly on capital adequacy and scale. While solvency remains essential for financial stability, the evidence indicates that it does not directly translate into superior efficiency or profitability unless complemented by effective management. Accordingly, insurers are encouraged to invest in managerial development, leadership succession planning, and data-driven decision-support systems to enhance operational efficiency and long-term performance. For policymakers and supervisors, integrating governance and managerial assessments into supervisory review processes could improve early detection of inefficiencies and strengthen the resilience of the insurance sector as a whole.
