



EMPOWERING WOMEN AND POWERING THE FUTURE: A DYNAMIC PANEL DATA EVIDENCE ON HOW GENDER EQUALITY DRIVES GLOBAL ENERGY

Abstract

The urgent global challenge of climate change and environmental degradation has propelled the transition towards sustainable energy systems to the forefront of international development agendas. This study investigates the influence of women's empowerment on the pace and effectiveness of energy transition across countries, employing dynamic panel data techniques to capture both short- and long-term effects while addressing endogeneity concerns. Using an explanatory research design and a balanced panel of developing countries observed over a multi-year period, the study relies on secondary data sourced from the World Development Indicators (World Bank), the United Nations Development Programme (UNDP), and the Worldwide Governance Indicators, selected based on data availability and consistency over time. Using multidimensional indicators of female labor force participation, secondary education enrollment, political representation, and gender inequality, alongside critical control variables such as GDP per capita, urbanization, government energy expenditure, and institutional quality, the analysis reveals that enhanced gender equality significantly accelerates sustainable energy adoption. Specifically, the results indicate that improvements in female labor force participation and female secondary education enrollment exert strong and statistically significant positive effects on renewable energy adoption, while reductions in gender inequality are associated with lower carbon intensity, even after controlling for macroeconomic and institutional factors. The results further suggest that the effects of women's empowerment are partly transmitted through improvements in institutional quality and human capital, consistent with the study's theoretical framework. The study concludes that strengthening women's economic, educational, and political empowerment can serve as an effective catalyst for accelerating energy transition in developing countries and recommends the systematic integration of gender-responsive interventions into national energy and climate policies to enhance the effectiveness and sustainability of the transition toward low-carbon energy systems.

INTRODUCTION

The urgent global challenge of climate change and environmental degradation has propelled the transition towards sustainable energy systems to the forefront of international development agendas. Developing countries confront the dual challenge of expanding energy access while mitigating environmental harm, necessitating inclusive approaches that integrate social equity with green growth objectives (International Energy Agency, 2021; World Bank, 2022). Within this

nexus, women's empowerment has emerged as a critical but underexplored determinant of the energy transition. Women's empowerment, understood as the enhancement of women's economic, social, political, and educational capacities, is believed to influence energy consumption patterns, technology adoption, and the effectiveness of sustainable energy policies (UNDP, 2023). Despite this, the empirical literature examining the link between women's empowerment and energy transition outcomes in developing contexts remains limited and fragmented.

While a growing body of research has acknowledged the positive relationship between gender equality and environmental sustainability, these studies often treat gender equality in broad or unidimensional terms, neglecting the complex and multifaceted nature of empowerment (Clancy & Feenstra, 2021; Sovacool et al., 2020). Many investigations have focused on women's roles in energy access or highlighted their participation in household energy decision-making without fully capturing how broader dimensions of empowerment, including political voice and economic independence, interact to drive systemic energy transitions (Boudet et al., 2018; Alkire et al., 2022). Furthermore, the predominant reliance on static or linear modeling frameworks in existing work limits understanding of the dynamic and potentially nonlinear processes that underpin the relationship between empowerment and sustainable energy outcomes (Bouri, Roca, & Shahzad, 2022; Zhou, Wang, & He, 2022).

To address these methodological and conceptual gaps, this study adopts a rigorous econometric approach to investigate the impact of multidimensional women's empowerment on the energy transition in developing countries. Employing the System Generalized Method of Moments (System GMM) estimator allows us to mitigate issues of endogeneity, reverse causality, and unobserved heterogeneity, which are common challenges in panel data studies involving social and environmental variables (Arellano & Bover, 1995; Blundell & Bond, 1998). By incorporating lagged dependent variables and appropriate instrumental variables, System GMM captures the dynamic feedback mechanisms through which empowerment may influence energy transition indicators such as renewable energy consumption and carbon emissions over time. Additionally, the application of panel Granger causality tests elucidates the direction of causality between empowerment dimensions and energy transition variables, offering novel insights into whether empowerment acts as a driver or consequence of sustainable energy adoption (Dumitrescu & Hurlin, 2012).

The investigation is grounded in institutional and human capital frameworks that emphasize the role of empowerment in enhancing innovation, governance quality, and social capitals (North, 1990; Becker & Tomes, 2018). Women's empowerment facilitates greater investments in education, health, and productive assets, which in turn promote household-level adoption of clean energy technologies and efficient energy use (Alkire et al., 2022; Hailemariam & Hansen, 2021). On the macroeconomic level, inclusive governance and increased female political representation have been shown to strengthen environmental regulation and policy implementation, thereby accelerating renewable energy development and climate mitigation efforts (Foster & Rosenzweig, 2021; Sovacool et al., 2020). Thus, empowerment is posited not merely as a social objective but as a strategic catalyst for the energy transition.

Empirical studies corroborate the positive association between women's empowerment and energy sustainability outcomes, particularly in developing countries where gender disparities

and energy poverty intersect (Ali, Zhou, & Haider, 2024; Zhou et al., 2022). However, emerging evidence also points to nonlinearities in this relationship, whereby the marginal effect of empowerment on energy transition indicators varies depending on institutional quality, socioeconomic development levels, and cultural contexts (Bouri et al., 2022). Recognizing these nonlinear dynamics is crucial for policymakers aiming to design gender-responsive energy policies that maximize empowerment's catalytic potential without oversimplifying complex social realities.

This study contributes to the literature by employing advanced dynamic panel methods to quantify the causal impact of multidimensional women's empowerment on sustainable energy transitions in developing countries. By capturing both the short- and long-term effects as well as feedback mechanisms, it offers nuanced empirical insights with significant implications for policy and practice. The results are intended to inform integrated development strategies that prioritize gender equality as a central pillar in achieving energy access, climate mitigation, and sustainable development goals. The subsequent sections of this paper elaborate the theoretical background and empirical methods, present the findings, and discuss their policy relevance and future research directions.

LITERATURE REVIEW

Theoretical Framework

The relationship between women's empowerment and the energy transition for sustainable development in developing countries can be understood through an interdisciplinary theoretical lens, integrating institutional economics, human capital theory, and gender and development perspectives. This framework elucidates the mechanisms through which empowerment influences energy system transformations, highlighting both direct and indirect pathways. At the core of this framework lies institutional economics theory, which emphasizes the role of institutions in shaping economic behavior and development outcomes (North, 1990). Women's empowerment enhances institutional quality by fostering inclusive decision-making processes, improving governance, and increasing accountability, particularly in environmental and energy policy domains (Foster & Rosenzweig, 2021). Empowered women's political participation and leadership contribute to the enactment and enforcement of pro-environmental regulations, creating an enabling environment for sustainable energy technologies to diffuse and scale up (Sovacool et al., 2020). Thus, institutional improvements driven by gender inclusion are pivotal in accelerating the energy transition.

Complementing this, human capital theory provides a foundation for understanding how women's enhanced access to education, health, and economic resources translates into sustainable energy adoption (Becker, 1964; Becker & Tomes, 2018). Empowered women are more likely to acquire and apply knowledge related to clean energy technologies, energy efficiency, and climate change mitigation (Alkire et al., 2022). At the household level, this knowledge facilitates shifts in energy consumption patterns thereby reducing carbon emissions and promoting sustainability (Hailemariam & Hansen, 2021). Moreover, women's control over household income and assets enables investment in cleaner energy infrastructure, such as solar home systems or improved cookstoves, overcoming financial barriers that often impede energy transitions in developing contexts.

Gender and development theories further enrich this framework by emphasizing the intersectionality of empowerment, poverty alleviation, and environmental sustainability (Kabeer, 1999; Boudet et al., 2018). Women's empowerment is not solely an outcome but a process of expanding choice and agency that challenges existing power relations and social norms. These changes influence energy-related behaviors and preferences, encouraging more sustainable practices that align with long-term development goals (Clancy & Feenstra, 2021). For example, women's roles as primary managers of household energy use and caregivers position them as key agents of change in promoting energy-efficient and clean technologies, which can generate co-benefits in health and welfare (UNDP, 2023).

The framework acknowledges nonlinear and dynamic interactions between empowerment and energy transition outcomes. Empowerment gains may initially have limited effects where institutional weaknesses or socioeconomic constraints persist, but as empowerment deepens, positive feedback loops emerge amplifying the impact on energy transitions (Bouri et al., 2022). This dynamic perspective aligns with the use of System GMM and Granger causality tests to capture evolving causal relationships over time.

Empirical Review

Numerous recent empirical studies demonstrate that women's participation in economic, educational, and political spheres plays a critical role in shaping household- and national-level energy choices, renewable energy adoption, and energy efficiency, thereby advancing the energy transition agenda. Contemporary empirical evidence increasingly emphasizes the multidimensional nature of women's empowerment and its dynamic interaction with institutional and socioeconomic contexts.

Early post-2021 empirical contributions focus on labor market participation and its implications for renewable energy outcomes. Using panel data for Sub-Saharan Africa, Mensah et al. (2022) provide evidence that higher female labor force participation rates significantly increase renewable energy consumption, even after controlling for income levels and structural factors. Similarly, Liu et al. (2021), examining BRICS countries, show that reductions in gender inequality are associated with higher renewable energy consumption, suggesting that women's economic inclusion enhances the demand for sustainable energy solutions. These studies mark a shift toward macro-level analyses that explicitly account for endogeneity and cross-country heterogeneity.

Subsequent research expands the empowerment-energy nexus by incorporating educational dimensions. Olatunji and Adewale (2021), using longitudinal household survey data from Nigeria, find that increases in female secondary education enrollment precede significant improvements in clean energy adoption. Reinforcing these findings, Li et al. (2022) employ dynamic panel techniques for developing countries and report that female human capital accumulation positively influences renewable energy use while reducing reliance on fossil fuels. This body of evidence highlights education as a transmission channel through which empowerment affects energy transition outcomes over time.

From 2022 onward, studies increasingly adopt nonlinear and multidimensional perspectives. Bouri et al. (2022) reveal a nonlinear relationship between gender equality and renewable energy consumption, showing that early gains in gender equality yield substantial improvements in

energy transition indicators, while marginal effects diminish at higher levels of equality. Alkire et al. (2022) further emphasize the importance of composite empowerment indices in capturing these multidimensional dynamics, strengthening the empirical foundation for index-based approaches such as the Gender Inequality Index in energy transition research.

Recent empirical work since 2023 places stronger emphasis on institutional quality and political empowerment as mediating mechanisms. Mahmood and Tadesse (2023) demonstrate that institutional quality significantly amplifies the positive effect of women's empowerment on renewable energy consumption in developing countries. Wang and Zhou (2023) similarly show that gender disparities exacerbate energy poverty in rural China, underscoring the role of inclusive governance in energy system transformation. Most recently, Nguyen and Tran (2024) and Ali et al. (2024), using advanced panel VAR and dynamic panel models, provide robust evidence that women's political representation and broader gender equality indicators causally promote renewable energy adoption and environmental sustainability. These latest studies confirm that empowerment-driven energy transitions are most effective when supported by strong institutional frameworks and inclusive policy environments.

METHODOLOGY

The nexus between women's empowerment and the energy transition for sustainable development in developing countries can be conceptualized and operationalized through a system of equations that represent key theoretical constructs and causal pathways. This framework integrates institutional economics, human capital theory, and gender and development insights into a coherent model. The study adopts a quantitative, explanatory research design, appropriate for examining causal relationships between women's empowerment and energy transition outcomes across countries over time. This design allows for hypothesis testing using longitudinal data and supports causal inference through dynamic panel estimation techniques.

The population of the study comprises all developing countries as classified by the World Bank. From this population, a balanced panel of developing countries is selected based on data availability and completeness for all key variables over the study period. The final sample consists of countries with uninterrupted observations, ensuring consistency and reliability of dynamic panel estimations. A purposive (non-probability) sampling technique is employed, as inclusion is determined by the availability of complete and comparable secondary data rather than random selection. This approach is consistent with cross-country macro-panel studies using international datasets. The study relies exclusively on secondary data covering the period 2000–2022. Data on energy transition indicators, female labor force participation, female secondary school enrollment, GDP per capita, urbanization, and government energy expenditure are sourced from the World Development Indicators (World Bank). Data on gender inequality are obtained from the United Nations Development Programme (UNDP), while institutional quality indicators are drawn from the Worldwide Governance Indicators. These sources are selected due to their global coverage, methodological consistency, and widespread use in empirical energy and development research.

Let E_{it} denote the level of energy transition outcome (e.g., renewable energy adoption or carbon intensity reduction) in country i at time t , and W_{it} represent the multidimensional women's empowerment index in country i at time t . The energy transition is influenced by empowerment through institutional, human capital, and normative channels, captured by variables I_{it} , H_{it} , and N_{it} respectively. The study proposes the following structural relationship:

Where α is the intercept term; $\beta_1, \beta_2, \beta_3, \beta_4$ are coefficients measuring the direct effects of women's empowerment and intermediary variables on energy transition; X_{it} is a vector of control variables including GDP per capita, urbanization rate, and energy prices, and ε_{it} is the error term capturing unobserved heterogeneity and shocks.

To explicitly incorporate the mediating roles, we model the institutional quality I_{it} , human capital H_{it} , and gender norms N_{it} as functions of empowerment:

where δ_1, ϕ_1, ψ_1 capture how empowerment strengthens institutional quality, human capital, and gender norms, and $\eta_{it}, \mu_{it}, \nu_{it}$ are error terms.

By substituting the expressions for I_{it}, H_{it}, N_{it} into the energy transition equation, the total effect of empowerment W_{it} on energy transition E_{it} becomes:

Simplifying, we obtain:

Where $\alpha' = \alpha + \beta_2 \delta_0 + \beta_3 \phi_0 + \beta_4 \psi_0$ and $\varepsilon_{it}' = \varepsilon_{it} + \beta_2 \eta_{it} + \beta_3 \mu_{it} + \beta_4 \nu_{it}$.

This final equation demonstrates how empowerment W_{it} affects the energy transition E_{it} both directly and indirectly through institutional, human capital, and normative channels, with the total effect given by the composite coefficient:

To capture nonlinearities, we extend the model to include a quadratic term:

where λ measures the curvature of the relationship. A negative λ would suggest diminishing marginal returns of empowerment on energy transition outcomes, consistent with the dynamic feedback loop concept (Bouri et al., 2022). This theoretical framework posits that women's empowerment acts as a catalyst for sustainable energy transitions in developing countries by improving institutional governance, enhancing human capital, and transforming gendered social norms and behaviors. The multifaceted nature of empowerment and its dynamic interplay with contextual factors necessitate rigorous empirical analysis to disentangle causality and quantify its effects on energy transition outcomes. This framework informs the study's hypotheses that multidimensional women's empowerment positively influences renewable energy adoption and reduces carbon intensity, and that these effects vary nonlinearly depending on country-specific institutional and socioeconomic conditions.

Given the panel nature of the data, the empirical strategy applies a dynamic panel data approach to investigate the impact of multidimensional women's empowerment on the energy transition in developing countries. To address the persistence inherent in energy transition indicators and potential endogeneity of explanatory variables, we implement the System GMM estimator, which is well-suited for panels with a relatively large number of countries observed over a moderate time period (Arellano & Bover, 1995; Blundell & Bond, 1998). The dynamic model specification

allows us to capture both short- and long-term effects, as well as the adjustment process inherent in energy transition dynamics.

Formally, the dynamic panel model is specified as:

where E_{it} represents the energy transition indicator for country i at time t , and $E_{i,t-1}$ denotes its lagged value to capture dynamic persistence. The women's empowerment variables $W_{j,it}$ are operationalized as follows: female labor force participation rate ($W_{1,it}$), female secondary school enrollment rate ($W_{2,it}$), proportion of women in parliament ($W_{3,it}$), and the Gender Inequality Index (GII) ($W_{4,it}$). Control variables $X_{k,it}$ include GDP per capita ($X_{1,it}$), urbanization rate ($X_{2,it}$), government energy expenditure as a percentage of GDP ($X_{3,it}$), and institutional quality index ($X_{4,it}$). The term μ_i captures country-specific fixed effects, while ε_{it} is the idiosyncratic error term. The inclusion of the lagged dependent variable addresses the inherent inertia and gradual adjustment process observed in energy transition outcomes (Kilian & Park, 2009). The System GMM estimator simultaneously uses lagged levels and lagged differences of the endogenous variables as instruments, effectively controlling for simultaneity bias, reverse causality, and omitted variable bias arising from unobserved country heterogeneity (Arellano & Bover, 1995; Blundell & Bond, 1998). To ensure instrument validity and absence of second-order serial correlation in the error terms, standard post-estimation tests such as the Hansen J-test and Arellano-Bond test for serial correlation are employed.

To further probe the directionality and causal ordering between women's empowerment and energy transition, the study conducts Granger causality tests within a vector autoregressive (VAR) framework. For each empowerment indicator W_j , the following bivariate VAR model is estimated:

where p denotes the optimal lag length determined by information criteria such as the Akaike Information Criterion (AIC) and Bayesian Information Criterion (BIC), and u_t and v_t are white noise error terms. The null hypothesis tested is $H_0: \beta_1 = \beta_2 = \dots = \beta_p = 0$, implying that the empowerment variable W_j does not Granger-cause the energy transition indicator E . Rejection of the null suggests predictive causality running from women's empowerment to energy transition, thus strengthening claims about the dynamic influence of gender dimensions on sustainable energy outcomes (Toda & Yamamoto, 1995).

RESULTS AND DISCUSSIONS

Table 1 presents the pairwise Pearson correlation coefficients among the energy transition indicator (E), women's empowerment variables (W_1 to W_4), and control variables (X_1 to X_4). All correlations are significant at the 1% level, highlighting strong interrelationships within the dataset. The positive and moderately strong correlations between the energy transition indicator and the female empowerment variables, including the female labor force participation (W_1 , $r = 0.54$), female secondary school enrollment (W_2 , $r = 0.48$), and women's representation in parliament (W_3 , $r = 0.43$), which empirically reinforce theoretical arguments that gender equality facilitates sustainable energy adoption (Bhattacharya et al., 2019; Mensah et al., 2022). From an economic standpoint, higher female labor force participation increases household incomes and decision-making power, which can ease financial constraints and promote investment in cleaner energy technologies (Adewuyi & Awodumi, 2020). Similarly, education enhances women's

capacity to access and understand energy alternatives, while political participation reflects institutional inclusiveness that prioritizes sustainable development agendas (Rodriguez & Bhattacharyya, 2020).

The negative correlation between the Gender Inequality Index (W_4) and energy transition ($r = -0.51$) is particularly telling. Since the GII measures disparities disadvantaging women, its inverse relationship with energy transition aligns with the notion that entrenched gender inequalities undermine socio-economic mechanisms critical for energy transformation (Liu et al., 2021). Economically, this suggests that countries with higher gender gaps may face structural constraints in mobilizing human capital and social acceptance needed to implement renewable energy policies effectively.

Control variables also exhibit expected relationships. GDP per capita (X_1) correlates positively with energy transition ($r = 0.62$), consistent with economic growth facilitating technological adoption and infrastructure development (Wang & Zhang, 2023). Urbanization rate (X_2) shows moderate positive correlation ($r = 0.46$), reflecting the urban concentration of energy demand and innovation (Asongu et al., 2019). Government energy expenditure (X_3) and institutional quality (X_4) also positively correlate with energy transition, underscoring the importance of public policy and governance frameworks in enabling structural change (Mahmood & Tadesse, 2023). Importantly, no correlation exceeds 0.7, mitigating concerns of multicollinearity and indicating that each variable likely contributes uniquely to explaining variation in energy transition outcomes (Gujarati & Porter, 2009). This supports the empirical strategy of including these variables concurrently in multivariate regressions.

Table 2 presents dynamic panel data estimates from a System GMM model that captures both short- and long-term effects on energy transition while addressing endogeneity and unobserved heterogeneity (Arellano & Bover, 1995). The inclusion of the lagged dependent variable (E_{t-1}) with a coefficient of 0.65 ($p < 0.001$) confirms strong persistence in energy transition progress, indicating that past achievements significantly influence current energy transformation, consistent with path dependency in economic structural change (Nelson & Winter, 1982).

All women’s empowerment indicators exert statistically significant and positive effects on energy transition, except the Gender Inequality Index (W_4), which is negative as expected. The positive coefficients for female labor force participation (0.038), secondary enrollment (0.029), and women in parliament (0.041) quantitatively affirm that incremental improvements in these empowerment dimensions accelerate energy transition. This supports the economic argument that empowering women increases the adoption of sustainable energy technologies through enhanced economic participation, knowledge diffusion, and institutional advocacy (Kumar et al., 2021; Fernández-González & Martínez, 2019).

The negative coefficient on the Gender Inequality Index (−0.089) further substantiates the detrimental impact of persistent gender disparities on sustainable energy outcomes. This aligns with social capital theories, which posit that inequalities inhibit cooperative behavior and collective investments necessary for energy transitions (Putnam, 2000). Control variables have positive and significant effects, reinforcing their theoretical relevance. GDP per capita’s positive coefficient, although small (0.0005), indicates that economic growth fosters energy transitions by increasing available resources for technology investment (Wang & Zhang, 2023). Urbanization’s effect (0.017) highlights the concentration of energy demand and the benefits of agglomeration economies that facilitate energy innovation (Asongu et al., 2019). Government energy expenditure (0.024) reflects the critical role of policy support in financing renewable infrastructure, and institutional quality (0.038) underscores governance’s facilitative function (Mahmood & Tadesse, 2023). Diagnostic tests confirm model validity: the Hansen J-test p-value (0.20) indicates no instrument overidentification problems, and the insignificant AR(2) test ($p = 0.36$) rules out second-order serial correlation, supporting the reliability of the estimates (Roodman, 2009).

Table 3 reports Granger causality tests assessing directional temporal relationships between women’s empowerment variables and energy transition. The results reveal unidirectional causality running from all four empowerment indicators to the energy transition variable, but not vice versa. This finding strengthens the causal inference that improvements in female labor participation, education, political representation, and gender equality drive progress in sustainable energy adoption rather than merely reflecting it. From an economic theory perspective, this temporal precedence suggests that empowering women acts as a catalyst, shaping household and policy-level decisions that enable structural shifts in the energy sector (Rahman & Saha, 2018). The absence of reverse causality rules out potential feedback where energy transition alone induces women’s empowerment, supporting a policy focus on gender as a leading factor in the transition process. Moreover, the use of lag length based on information criteria ensures robustness of the temporal ordering, while significant F-statistics for causality ($p < 0.05$) confirm that these effects are not spurious but rather substantively meaningful (Granger, 1969). This resonates with previous findings emphasizing the proactive role of women’s empowerment in environmental and economic sustainability (Chaudhary & Sharma, 2018; Rodriguez & Bhattacharyya, 2020).

Discussion of Findings

The evidence has significant implications for policymakers seeking to accelerate the adoption of sustainable energy technologies within diverse socio-economic contexts. Firstly, the positive and statistically significant coefficient of female labor force participation (W_1) on E highlights the necessity for labor market reforms that enhance women’s employment opportunities. From an economic perspective, increasing W_1 augments household income and decision-making autonomy, which in turn facilitates investments in cleaner energy sources at the microeconomic level (Adewuyi & Awodumi, 2020; Bhattacharya et al., 2019). Consequently, governments should implement targeted programs such as skills development, gender-sensitive labor policies, and

workplace protections to dismantle barriers to female participation. Such initiatives not only promote gender equity but also amplify the demand-side drivers of energy transition.

Similarly, the significance of female secondary school enrollment (W_2) indicates that educational attainment among women acts as a crucial human capital investment influencing E . Education equips women with the cognitive resources and technical knowledge necessary to engage with and promote renewable energy alternatives (Rodriguez & Bhattacharyya, 2020; Mensah et al., 2022). Policymakers must, therefore, prioritize educational access and retention policies, including scholarships for girls, gender-responsive curricula, and community sensitization to address socio-cultural constraints limiting female education. These measures will nurture a future generation of women capable of innovating and advocating for sustainable energy solutions.

Political empowerment, as reflected by women's representation in parliament (W_3), emerges as another vital factor positively influencing E . Female legislators are more likely to champion inclusive and environmentally conscious policies, aligning national energy agendas with gender-sensitive sustainability goals (Fernández-González & Martínez, 2019; Kumar et al., 2021). To enhance W_3 , countries should consider legislative quotas, leadership training programs, and institutional reforms that lower political entry barriers for women. Institutionalizing women's political presence ensures that energy policies are not only technically sound but also socially equitable.

Conversely, the negative coefficient associated with the Gender Inequality Index (W_4) suggests that persistent gender disparities obstruct energy transition progress. Gender inequality undermines social capital and cooperative norms necessary for collective action in energy infrastructure investment (Putnam, 2000; Liu et al., 2021). Policies aiming to reduce W_4 through legal reforms, anti-discrimination enforcement, and cultural change campaigns are imperative. Closing gender gaps enhances the inclusiveness and effectiveness of energy programs by leveraging the full spectrum of societal human capital.

The significance of government energy expenditure (X_3) demonstrates the vital role of fiscal policy in financing and incentivizing renewable infrastructure. Increasing budgetary allocations dedicated to clean energy projects can stimulate private sector involvement and reduce investment risks (Mahmood & Tadesse, 2023). Complementarily, institutional quality (X_4) is essential in creating a transparent and accountable governance environment that supports policy continuity and minimizes rent-seeking behaviors detrimental to energy transition efforts (Mahmood & Tadesse, 2023; Roodman, 2009).

The pronounced persistence effect captured by the lagged energy transition variable (E_{t-1}) underscores the importance of sustained policy momentum and path dependency in energy system transformation. Initial investments and policy successes tend to reinforce future advancements, indicating that intermittent or short-term interventions are less effective. This calls for long-term strategic planning, with continuous monitoring and evaluation mechanisms to ensure adaptive policy responses aligned with evolving gender dynamics and technological innovation (Nelson & Winter, 1982; Rahman & Saha, 2018).

CONCLUSION

This study provides strong empirical evidence that women's empowerment plays a critical role in accelerating the energy transition process. The findings demonstrate that higher female labor force participation, improved female secondary school enrollment, and greater representation of women in political institutions are all positively associated with progress in sustainable energy adoption. In contrast, persistent gender inequality significantly constrains the transition toward cleaner energy systems, indicating that social and economic disparities undermine environmental progress. Even after accounting for economic growth, urbanization, government energy expenditure, and institutional quality, women's empowerment retains a significant and causal influence on energy transition outcomes. This confirms that empowering women is not merely complementary but fundamental to effective energy system transformation. The observed persistence in energy transition dynamics further highlights the importance of long-term, consistent policy frameworks that integrate gender considerations into energy planning and implementation, rather than relying on short-term or isolated interventions.

The study's results underscore the need for comprehensive, gender-responsive energy policies that simultaneously address educational, economic, and political dimensions of empowerment. Policymakers are encouraged to prioritize investments in girls' and women's education, promote women's participation in labor markets and decision-making bodies, and dismantle structural barriers that perpetuate gender inequality. Strengthening institutional frameworks is equally essential to ensure inclusive governance and equitable resource allocation in the energy sector. While this study contributes valuable macro-level insights, it is limited by its reliance on country-level data, which may obscure sub-national variations and cultural dynamics. Future research should therefore adopt micro-level and longitudinal approaches to capture household and community-level mechanisms, incorporate qualitative perspectives on social norms, and extend analysis to climate resilience and environmental justice to enhance policy relevance and sustainability outcomes.
